MINUTES

I. CALL TO ORDER.

Chairman Baca called the meeting to order at approximately 9:04 a.m. All three Board members were present in person.

II. REVIEW AND APPROVAL OF AGENDA FOR MONDAY, JULY 21, 2025.

Member Perlman moved to approve today's agenda. Member Montoya seconded. Voted and passed 3-0.

III. REVIEW AND APPROVAL OF MEETING MINUTES FOR JULY 7, 2024.

Member Montoya moved to approve the minutes for June 2, 2025. Member Perlman seconded. Voted and passed 3-0.

IV. PUBLIC COMMENTS: None.

V. PRESENTMENT AND APPROVAL OF ORDERS:

- **LB 24-15 ORDER OF DISMISSAL (MOTION FOR PARTIAL RECONSIDERATION).**

Chairman Baca requested clarification regarding the Order of Dismissal (Partial). Attorney Frederick Mowrer confirmed that the reference to SOP 3-1 is stricken from paragraphs 14 and 17 of the Complaint and will be removed and are dismissed with prejudice.

- **LB 24-15 STIPULATED MOTION TO CONTINUE.**

Attorney Mowrer stated that he spoke to Mr. Lewis who is in concurrence and advised that the request stems from the unavailability of a few key witnesses who were not able to attend today's hearing due to work obligations.

Chairman Baca moved to approve the Stipulated Motion to Continue. Member Montoya seconded. Voted and passed 3-0.
