MINUTES

I. CALL TO ORDER.

Chair Sonja Brown called the meeting to Order at approximately 2:03 p.m. All board members were present via Zoom.

Union Representative Joel Villareal appeared on behalf of the Grievant and argued his position requesting that the Board reverse the Hearing Officer's recommendation.
