I. CALL TO ORDER.

Chairman Baca called the meeting to order. Board members Bruce Perlman and Juan Montoya were also present.

Mr. Montalbano presents to the board that he will be sitting in on all 3 cases LB 23-03, 23-04, and 23-05. LB 23-03 is amended due to typos in the body of the PPC. City will file a response to the amended PPC. LB 23-03 will be set for a schedule status hearing on March 20th.

Assistant City Attorney Jessica Serrano states the City's response is not due until March 8th, 2023. States 3.11 rule of screening and investigation, the PPC does not have adequate information and does not state the required provisions of cellphones. The city will submit a motion to dismiss based on these grounds. Mr. Montalbano states the willing to work with 2006 the city. Chairman Baca instructs Mr. Montalbano to file an amendment by March 6th, 2023 with a status conference on March 20th, 2023.
