• LB 15-15, PROHIBITED PRACTICE COMPLAINT FILED BY ALBUQUERUQUE POLICE OFFICERS' ASSOCIATION ON BEHALF OF SHAWN CASAUS AGAINST THE CITY OF ALBUQUERQUE AND ALBUQUERQUE POLICE DEPARTMENT FOR REFUSING TO HONOR THE TERMS OF THE COLLECTIVE BARGAINING AGREEMENT AND PAST PRACTICE OF THE BIDDING PROCESS FOR SERGEANTS. Samantha Hults, Deputy City Attorney and Attorney Jason Burnette appeared on behalf of the City. Attorney John D'Amato appeared on behalf of the Albuquerque Police Officers' Association. Ms. Hults stated that the parties reached a settlement agreement that settles this case pending a District Court case regarding breach of contract of EEOC charge and Mr. Casaus will receive a ceremonial promotion and the City agrees to pay 652 to settle the claims. She also stated that the IPRA charge will not be part of the settlement agreement and the City will submit an Order of Dismissal.
