The undersigned Albuquerque Police Officers Association (APOA) representative is hereby submitting APOA membership cards pursuant to Sections 3-2-7 (A) and 3-2-7 (D) (1) of the City of (City) Labor Management Relations Ordinance (LMRO) and Rules 2.7, 2.8, 2.10 and 2.31 of the City's Labor Management Relations Board (Board). The APOA requests the Board certify the APOA as the exclusive bargaining agent for all City Internal Affairs Force Division Investigators employed with the City's Police Department.

Since this petition includes APOA membership cards authorizing and designating the APOA as the exclusive bargaining agents from thirteen (13) investigators, the APOA requests immediate certification of the APOA as the employees' exclusive bargaining agent.

The APOA is currently the bargaining agent for the City's police officers and prisoner transport operators. The APOA is located at 3813 Hawkins N.E, Albuquerque, NM 87109. The City's Police Department is headquartered at 400 Roma NW, Albuquerque, NM 87102, and their phone number is 505-768-2200.

The investigators are currently unrepresented by a bargaining agent. The 15 investigators who have signed cards represent all the Force Division investigators. The investigators work at the Police Headquarters building.


