2	AMENDING THE ALBUQUERQUE ALCOHOLIC LIQUOR ORDINANCE TO
3	MODIFY THE DEFINITION OF A "PUBLIC CELEBRATION".
4	BE IT ORDAINED BY THE COUNCIL, THE GOVERNING BODY OF THE CITY OF
5	ALBUQUERQUE:
6	SECTION 1. Chapter 13, Article 2, Section 2 of the Revised Ordinances of
7	Albuquerque, New Mexico, 1994, the "Definitions" section "Alcoholic Liquor
8	Ordinance" is hereby amended as follows:
9	"§ 13-2-2 DEFINITIONS.
10	PUBLIC CELEBRATION. Any state or county fair, community fiesta,
11	cultural or artistic event, sporting competition of a seasonal nature or
12	activities held on an intermittent basis that are open or advertised to the
13	general public. For purposes of this definition, "intermittent basis" means only
14	that an activity occurs at a particular location with at least 48 hours before the
15	next separately permitted activity, and for no more than 12 hours within a
16	single day, or that the activity has been approved by the State Director
17	regardless of these limitations."
18	SECTION 2. Severability. If any section, paragraph, sentence, clause, word

or phrase of this Ordinance is for any reason held to be invalid or unenforceable by any court of competent jurisdiction, such decision shall not affect the validity of the remaining provisions of this Ordinance.
