# **Draft FH Community Policing Council Recommendation**

Date: 5-9-2019

Title: APD Youth Community Outreach

**Recommendation**: APD shall assign a patrol officer and a member of APD leadership to be part of the Foothills Area Command Community Policing Council Youth and Outreach Committee. Ideally this committee (FH CPC members and APD assigned Officer(s)) will commit to meet monthly for a minimum of three months and to follow up quarterly.

**Purpose of Recommendation**: To establish a plan of action to increase police outreach to identify and serve at-risk youth in the Foothills Area Command. This is part of a larger effort to facilitate a consistent and predictable APD dialogue with youth, to re-establish APD-public trust, to promote public safety, and to achieve documented positive APD community engagement.
