- **6.** Darlene Castillo MANA de Albuquerque Board President

- MANA's goal is to help build the Latino Community in Albuquerque and help others.
- There are 67 Adult members.
- Mentorship program Open to eleven year-old, to seventeen year-old middle and high school girls who take part part in the workshops on development and resources they can take home.
- Scholarships available for the senior girls in high school
- Donations are welcome.
- MANA currently has an all-volunteer staff, and has a goal of paying staffmembers

7. External Force Investigation Team (EFIT) Bill Hurlock and Darryl Neier

- EFIT came out via joint order by the United States Department of Justice and the City of Albuquerque in 2016
- EFIT files quarterly progress reports on Internal Affairs training.
- First amended stimulated order required the city to modify their contract with EFIT
- EFIT 2 investigates all use of force incidents that occurs between June 1, 2020 to July 16, 2022. The date EFIT took over they were not investigating in full or partial by APD.
- EFOT went live on June 16, 20222 working on back log cases
- EFIT investigates current cases and got extended for another twenty-four months May 2022 to May 2024
- Next report due November 23rd.
- There was an original backlog of 667 cases assigned to be investigated by EFIT and thirty cases are now complete.
- In the process of transitioning Use of Force investigations back to IAFD from EFIT
- The City's goal is to be fully compliant with CASA within 2 years.
- City and APD investigators are being graduated through a 3-tier system of rating.
