1. APD Presentations: Lt Garrett

Monthly crime report compared to January *These are based on calls for service in the foothills area command*

Robberies/Commercial: 2 Stolen Vehicles: 54 and 2 Warm-up Auto

Robbery/Residential: 0 Thefts

Robbery/Vehicle: 2 <u>Commercial Burglaries:</u> 16

Robbery to an Individual: 2 Residential Burglaries: 32

Auto Burglaries: 80

<u>Items left in vehicles that were stolen:</u> Amazon tablets, backpacks, tools, registration, fire arms, baby supplies, cell phones, credit/debit cards, WIC cards, purse/wallets, horse supplies, gym bag, jewelry, title to vehicle, invoice book, and sunglasses.

Q: What is a level two?

A: Level 2 is force that causes injury, could reasonable be expected to cause injury, or result in a complaint of injury.

Level 1 is force that is likely to cause only transitory pain, disorientation, or discomfort during its application as a mean of gaining compliance.

Level 3 is force that results in, or could reasonably result in, serious physical injury, hospitalization, or death.

Q: Number of burglaries, they seem to stay high, is there a team of burglars working with each other that is operating this area?

A: In the FH area command, we take information and put it on the map and color coded by the activity. Foothills is unique, it is not blogging together. There are people that work together, but it's not uncommon.

2. Pulse of the Neighborhood

3. Speaker: A. Blair Dunn

Blair Dunn spoke about misconceptions, constitution amendments, dealing with the constitutional law, as well as holding judges accountable. One of the topics also talked about was about the Red Flaw Law. Part of the issue, this was to prevent people from using firearms from suicide. Taking away the tool, will not have that much of an effect from violence.

Q: How many bases should we expect to be brought by the red flag law and how many situations have we experience in the last year or so?

A: Passing this law won't prevent anything,

Q: Red flag, employment, does it go on your records?

A: You can be charged by a crime you did not commit, it's not getting charged with a crime, it is confidential until you get charged.

Comment: Four hills, residential are grateful for Lt Garrett, the residents have been feeling safe since he started patrolling the area.

Q: Are there candidates for the foothills CPC?

A: We have a number of candidates that will be brought forward for discussion. The rules have been changed and members can be reinstated if they were removed. We hope within the few months we have more members.
