- What do you say about the number of officers retiring, leaving or separating during your leadership?
- How do you plan to fix the relationship between APOA and APD?
- Please explain why officers are parked at the APD Substations, rather than on the streets?
- What is the promotion process between Lt. and Cmdr.? Who is involved in making the decision?
- What is the mentoring program for new recruits?
- Will you establish stronger communication with victims of crime?
- What will APD do about the increase in property crime that will occur with marijuana now legal in Albuquerque?
- What is being done to increase shortages in the narcotics department?
- What is the status of the investigation of the homicide a few days ago on San Pedro and Osuna?
- Will the Citizen's Policing Academy continue to be open to ordinary citizens, or will it be restricted to CPC and CPOA board members?
- Will you make public your goals for the department? How do you plan to accomplish them, what are the challenges?
- Is the Community Contact App working?
