- 1. Call to order -6:32 PM
- 2. CPC Overview Who we are What is our mission

- 5. APD Chief of Police Harold Medina
 - State legislation session had topics about losing qualified immunity and lost to law enforcement and their rights.
 - APD is under a settlement agreement with DOJ and a monitor that brings challenges to the profession. Last year the monitoring report had comments on former administration with discipline and command staff.
 - Recruiting classes are more significant than in past decades. In October, fortyseven cadets graduated. In December, they anticipate fifty-three, with twelve going to CNM in January, totaling sixty-five for the classes. In the spring, a repeat of the process with sixteen cadets at CNM gets transferred to APD in December.
 - They are committed to hiring many PSA's and obtaining civilian support staff. Before the balloon fiesta, seventeen PSA's graduated, which lifted the burden on the sworn police officers. APD is committed to starting another PSA academy.
 - Chief Medina reported that they added support to the investigation unit in terms of the digital intelligence team and solved a homicide case. There are changes in

investigations in providing training within the last and developing the first detective's academy.

• Personnel:

• Short staff across APD and violent crime cases have not been followed upon on time, including property crimes that are not getting investigated quickly.

• Crime:

All detectives worked violent crimes for forty-five days. In recent months, there was a slowdown for homicides and a slight increase in prior weeks, currently at its lowest in months for the year. If there are available resources, more cases get moved and people in custody.

- Personnel changes within the department
 - Cecily Barker, formerly Chief of Staff, is now Deputy Chief of Investigations
 - Josh Brown, formerly Valley Area Commander, is now Deputy Chief of field services
 - Cori Lowe, formerly Commander of compliance, is now Deputy Chief of Compliance
 - Changes will get made if needed.
- Property crimes are down, and violent crimes are up.
- The statistics on the seventy biggest agencies, Albuquerque crimes in homicides increased thirty-eight percent over the past two years.
- He stated that supporting funding, resources, and legislation to help fix all the portions of the criminal justice system. Also, take ownership when changes get made in APD (Albuquerque Police Department)
