- 4. Bernalillo Metropolitan Detention Center Staff
 - County-run jail, which is the largest jail in NM.
 - Under a federal lawsuit similar to APD, they are under the McClendon Settlement.
 - Cap population at 1950. As of three p.m. that afternoon, they counted 1789 inmates in custody. The number of inmates has been fluctuating. At one point, they had 110 beds left, but in the past couple of months, they've seen an increase in population.
 - House individuals who are waiting for the conclusion of their cases. People can
 come in and be held until their trial, released on bond, or released on their own
 recognizance by the judge.
 - People who are sentenced by the judge for 364 days or less to serve their sentence at the MDC. If they go longer, they go to the state department of corrections.
 - The population dashboard at bernco.gov updates every 15 minutes. The information breaks down population units by gender, age, transient, and race.
 - On the general population side, DEF-restricted housing, medical housing has the PAC unit, and a Psychiatric acute care unit.
 - CCP—People who are sentenced to be out in the community are monitored by MDC. Typically, they wear ankle monitors. As of today (8/7), 61 people were on ankle monitors.
 - Resource reentry center—It opened seven years ago. Last fiscal year, it released 20,000 people back into the community who came through it. It is open 24/7, and MDC gives advance notice of who is being released.
 - When someone gets released from MDC, they identify if that person has any mental health issues, substance use, or risk of going back and committing crimes.

They get assigned to certain case management groups within MDC. They have three teams.

- o Low level
- High to moderate
- o Discharge planning team.
- Needs assessment identify their behavioral health, medical, and social support.
