- 4. Old business –** Recommendation to file report from EFIT into the police officer’s file got adopted by APD.
- 5. Round table discussion with the Crisis Intervention Division Commander Matt Dietzel, ASC behavioral health supervisor Walter Adams, and Peter Cubra, representing the McClendon plaintiffs**
 - The discussion was about how CIT and ACS interact with the mental health community. There are different approaches that both CIT and ACS take when dealing with this group. APD officers and cadets get hours of training in CIT and de-escalation.
 - The Crisis Intervention Team is tasked with trying to prevent mass-casualty incidents.
 - Albuquerque Community Safety is tasked with non-violent incidents in order to free up APD for integral police work.
 - Attorney Peter Cubra represents the McClendon Subclass, which deals with illegal arrest and detainment issues.
 - APD SOP (standard operating procedure) 219-3; dealing with behavioral health issues.
 - APD SOP 2-55 Use of Force and de-escalation techniques. Can officers safely maintain contact?
 - Other APD SOP’s written about use of force.
 - APD mandatory use of force training
 - ACS uniform choices were designed with public trust in mind.
 - Mr. Cubra believes that unarmed city representatives should take more 911 calls.
 - Alternatives to police response, here in Albuquerque and other cities.

- Roundtable discussion, much of which centered on police shootings on people in behavioral crisis in 2022 when there were no firearms involved.
