Instructions for Public Participation for the December 15, 2020 Public Safety Committee meeting

- **Written Comments:** The Committee will take comment on the meeting's specific agenda items in written form via email through 1:00 pm on Tuesday, December 15. Web form submission for written comment can be found at <https://www.cabq.gov/dec-15-2020-written>. These comments will be distributed to all Committee members for review in advance of the meeting.
- **Virtual, Live Comments:** To provide real time verbal public comment over Zoom, participants must sign up for public comment by 1:00 p.m. on Tuesday, December 15. The sign-up sheet can be accessed at this link: <https://www.cabq.gov/dec-15-2020-live>
- **Note:** Participants must sign up for public comment with the Zoom username or phone number that they will be entering the Zoom meeting with so that they can be identified when accessing the meeting. Persons who do not provide this information will not be allowed into the meeting, but may still view the meeting via YouTube live: <https://youtu.be/YF88R5rwSnw>
- Participants will be an Attendee in the Zoom Webinar until the public comment period begins. The Zoom moderator will move you into the meeting room as Panelist when it's your turn to provide public comments.

- Public comment will be limited to 2 minutes or less, depending on the number of speakers signed up. Your time will start when you begin speaking and you will be informed when your time has concluded, at which point your microphone will be muted and your camera will be turned off.

- Please keep your comments germane to the topics on the agenda.
