Instructions for Public Participation at the February 10, 2021 Land Use, Planning and Zoning (LUPZ) Committee Meeting

- **Written Comments:** The Committee will take comment on the meeting's specific agenda items in written form via email through 1:00 pm on Wednesday, February 10th. Web form submission for written comment can be found at and <https://www.cabq.gov/feb-10-2021-written>. These comments will be distributed to all Committee members for review in advance of the meeting.
- **Virtual, Live Comments:** To provide real time verbal public comment over Zoom, participants must sign up for public comment by 1:00 p.m. on Wednesday, February 10th. The sign-up sheet can be accessed at this link: <https://www.cabq.gov/feb-10-2021-live>
- **Note:** Participants must sign up for public comment with the Zoom username or phone number that they will be entering the Zoom meeting with so that they can be identified when accessing the meeting. - Participants will be an Attendee in the Zoom Webinar until the public comment period begins. The Zoom moderator will move you into the meeting room as Panelist when it's your turn to provide public comments.
