### Instructions for Public Participation for the February 15, 2023 Hybrid Land Use, Planning, and Zoning Committee Meeting

- To provide in-person public comments or real time verbal public comment over Zoom to the Committee, everyone must sign up by 3:30 pm on the day of the meeting by completing this web form: <https://www.cabq.gov/feb-15-2023-comment>. Participants may sign up for a maximum of 2 agenda items per meeting. For members of the public without internet service, you may call our office at 505-768-3100 for assistance.
- Note: Participants providing comment via Zoom must sign up for public comment with the Zoom username or phone number that they will be entering the Zoom meeting with so that they can be identified when accessing the meeting. Persons who do not provide this information will not be allowed into the meeting, but may still view the meeting via YouTube live or in Zoom Webinar: <https://youtube.com/live/9u7tinaAjf4?feature=share>
- Participants will be an Attendee in the Zoom Webinar until the public comment period begins. The Zoom moderator will move you into the meeting room as Panelist when it's your turn to provide public comments.
