• To provide public comments to the Committee, in person or virtually, everyone must sign up by 4:00 pm on the day of the meeting by completing this web form: https://www.cabq.gov/apr-13-2022-comment

• Participants may sign up for a maximum of 2 agenda items per meeting. For members of the public without internet service, you may call our office at 505-768-3100 for assistance.

• Note: Participants providing comments virtually must sign up for public comment with the Zoom username or phone number they will be entering the Zoom meeting with so they can be identified when accessing the meeting. Persons who do not provide this information will not be allowed into the meeting, but may still view the meeting via Zoom Webinar or YouTube live: https://youtu.be/C\_puEXZ0XpM

• Participants will be an Attendee in the Zoom Webinar until the public comment period begins. The Zoom moderator will move you into the meeting room as Panelist when it's your turn to provide public comments.
