Instructions for Public Participation for the May 11, 2021 Public Safety Committee Meeting

- **Written Comments:** The Committee will take comment on the meeting's specific agenda items in written form via email through 1:00 pm on Tuesday, May 11th. These comments will be distributed to all Committee members for review in advance of the meeting.
- **Virtual, Live Comments:** To provide real time verbal public comment over Zoom, participants must sign up for public comment by 1:00 p.m. on Tuesday, May 11th. The sign-up sheet can be accessed at this link: <https://www.cabq.gov/may-11-2021-live>
- **Note:** Participants must sign up for public comment with the Zoom username or phone number that they will be entering the Zoom meeting with so that they can be identified when accessing the meeting.
