Instructions for Public Participation for the July 14th Committee of the Whole meeting.

- To provide real time verbal public comment over Zoom, participants must sign up for public comment by 1:00 p.m. on July 14. The sign-up sheet can be accessed at this link: <https://www.cabq.gov/july-14-2020>
 - o Note: Participants must sign up for public comment with the Zoom username or phone number that they will be entering the Zoom meeting with so that they can be identified when accessing the meeting. Persons who do not provide this information will not be allowed into the meeting, but may still view the meeting via YouTube live <https://youtu.be/Fc4NdAhSsnY>, through GOVTV on Comcast Channel 16, or on the GOVTV live stream at <https://www.cabq.gov/culturalservices/govtv>.
- Participants will standby in the Zoom virtual waiting room until the Zoom moderator moves them into the meeting.

Your time will start when you begin speaking and the meeting's Chairperson will let you know when your time has concluded, at which point your microphone will be muted and your camera will be turned off.**
