DMD	Department of Municipal Development	City Department that handles streets, city facilities, storm drains, traffic signals, and parking.
DPM	Development Process Manual	City Engineers refer to this manual for design specifications for infrastructure development improvements as well as to approve private sector development proposals.
DRB	Development Review Board	Board that makes decisions related to the City Subdivision Ordinance.
EHD	Environmental Health Department	City Department that handles air quality, food safety, pest management, urban wildlife and pharmaceutical disposal.
EIN	Employer Identification Number	A unique number that identifies the organization to the Internal Revenue Service.
EPC	Environmental Planning Commission	Reviews and approves requests regarding zone changes, site development plans, annexations, and amendments to the Zoning Code and Rank Plans.
FGO	Finance and Government Operations	Committee of the Council, made up of 5 Councilors.
HOZ	Historic Overlay Zones	A zoning district that is placed over an existing base zone or zones which is suitable for preservation and which has historical, architectural, or cultural significance.
HOA	Homeowners Association	An organization in a subdivision that enforces rules for properties within its boundaries.
IDO	Integrated Development Ordinance	The Integrated Development Ordinance is an update to the City's regulatory land use framework, including the zoning code. It's the implementation document complimentary to the recently adopted Comprehensive Plan.
LUCC	Landmarks and Urban Conservation Commission	Reviews and recommends requests based on historic properties that should be preserved or areas worthy of conservation.
LUHO	Land-Use Hearing Officer	Hears appeals of Environmental Planning Commission, Landmarks & Urban Conservation Commission and Development Review Board decisions. The City Council makes the final decision based on the hearing officer's report.
LUPZ	Land Use Planning and Zoning	Committee of the Council, made up of 5 Councilors.
MRA	Metropolitan Redevelopment Area	Areas identified by the Metropolitan Redevelopment Agency that promotes both housing and commercial redevelopment in distressed areas.
MRCOG	Mid Region Council of Governments	Multi-County governmental agency that helps our region plan for the future based on population growth projections.

MRGCD	Middle Rio Grande Conservancy District	Offers irrigation, flood control and responsible water conservation services to irrigators and farmers in the middle agricultural region of the state.
NA	Neighborhood Association	A group of residents, property owners, businesses, and non-profits who come together to form a community within a specific geographical area.
NAICS	North American Industry Classification System	The standard used by Federal statistical agencies in classifying business establishments for the purpose of collecting, analyzing, and publishing statistical data related to the U.S. business economy.
NAO	Notice And Order	Notice of a substandard building sent to property owner and posted on property. That lets the owner and public know that the building is unsafe to be occupied until all issues have been corrected.
NMDOT	New Mexico Department of Transportation	State department responsible for providing a safe and efficient transportation system for the traveling public while promoting economic development and preserving the environment of New Mexico.
NOV	Notice Of Violation	Notice sent to property owner advising of any zoning violations on a property and the corrective measure that needs to be performed to bring property into compliance with zoning ordinances.
ONC	Office of Neighborhood Coordination	Division responsible for supporting neighborhoods, connecting neighborhoods to City Departments, and maintaining neighborhood representative contact lists for official communications.
OSD	City Open Space, a division of the Parks & Recreation Department	Division that works to acquire and protect that natural character of land designated as major public Open Space.
PID	Public Improvement District	A special assessment area created at the request of the property owners within a designated boundary. These owners pay a supplemental assessment with their taxes, which the PID uses for services above and beyond existing City services.
PIO	Public Information Officer	The communications coordinator or spokesperson for a department. Typically responsible for sending out information to the media.
PSI-EXAM	Psychometrics Inc Exam	Construction Contractor's Licenses Database for the State of New Mexico. You must be in this database in order to obtain a building permit.
SAD	Special Assessment District	A geographic area in which the market value of real estate is enhanced due to public improvements. A tax is levied on individual property owners to recover the costs of the public improvement.
SOB	Sexually Oriented Business	Any business that deals with anything of a sexual nature including clothing, books, magazines, toys, sex aides, live entertainment, movies, etc.

TIDD	Tax Increment Development District	A public financing method that is used as a subsidy for redevelopment, infrastructure, and other community- improvement projects.
TRD	Taxation and Revenue Department of New Mexico	Charged with the task of collecting tax dollars and distributing them according to state law. It administers taxation, revenue and motor vehicle laws.
WTF	Wireless Telecommunications Facility	A facility that transmits and/or receives signals or waves radiated or captured by a wireless telecommunications antenna. It may include: antennas of all kinds including microwave dishes, horns, and other types of equipment for the transmission or reception of such signals, telecommunications tower or similar structures supporting said equipment, equipment buildings or cabinets, parking area, and/or other accessory development.
WUA	Water Utility Authority	See Albuquerque Bernalillo County Water Utility Authority (ABCWUA) above.
ZHE	Zoning Hearing Examiner	The Zoning Hearing Examiner conducts monthly public hearings regarding special exceptions to the Zoning Code. A special exception is the allowance to develop property in a manner different from what is prescribed by a particular zone category.
