1. Amend "SECTION 4" beginning page 5, line 27 of the committee substitute blueline draft as follows:

SECTION 4. COMPILATION. [Section '1' of this Ordinance is to be compiled as a new Article 25 in Chapter 9 of the Revised Ordinances of Albuquerque, New Mexico, 1994, titled "The Distressed Lodging Property Ordinance.,"] Section ['4'] ['2'] of this Ordinance amends, is incorporated in, and is to be complied as part of the Revised Ordinances of Albuquerque, New Mexico, 1994.

Explanation: This amendment updates the bill's "compilation" section to ensure all substantive provisions are properly incorporated into the City's code of ordinances.

1. Beginning page 3, line 7, amend Section 9-25-5(B) of the committee substitute as follows:

(B) Guest Logbook:

- i. **Maintain a secure, digital or physical logbook of all guest check-ins, including the name, address [if available], phone number [if available], and license plate(s) of all vehicles for the guest [if available], along with the room number and duration of stay. Records must be retained for a minimum of 45 days.**

Explanation: This amendment updates language around required information in the logbook to make it more flexible for guests who may not have an answer to the requested information.

FLOOR AMENDMENT NO. 3 TO C/S O-25-75

AMENDMENT SPONSORED BY COUNCILOR: Tammy Fiebelkorn

1. Beginning page 2, line 24, amend Section 9-25-5(A) of the committee substitute as follows:

(A) Guest Identification:

~~**[i.] A valid, government-issued photo identification (ID) must be presented by all guests upon check-in.]**~~

~~**[ii.] [i.] If payment is with a debit or credit card, the following information shall be retained for 45 days:**~~

- ~~**a) The name on the card; and**~~
- ~~**b) The card brand; and**~~
- ~~**c) The last four digits of the card.**~~

~~**[iii.] [ii.] A copy of the guest's photo ID [if available, or if not available then a clear, discernable, color still image of the guest that clearly depicts a full-face view of the person] must be retained for a minimum of 45 days and made available to the City upon request in accordance with applicable laws.**~~

Explanation: This amendment updates language around the required photo ID to ensure there's an option for guests who don't have a photo ID. This language would require the establishment's owner to take a photo with a choice in a variety of ways (security camera, desk camera, phone, etc.) if the guest is unable to present a Photo ID.
