2. Beginning on page 1, line 5, through page 2, line 3, strike all WHEREAS clauses in their entirety and insert the following:

[WHEREAS, safe, stable, and affordable housing is fundamental to the well-being of Albuquerque residents; and

WHEREAS, the City of Albuquerque faces a growing shortage of affordable housing options, leaving many individuals and families struggling to find housing within their financial means; and

WHEREAS, the Affordable Housing Fund will provide a dedicated revenue stream to support the development, preservation, and rehabilitation of affordable housing units across the city, and may also be used to fund housing assistance programs such as rental vouchers, housing navigation services, eviction prevention efforts, and other supports that help low- and moderate-income residents access and maintain stable housing; and

WHEREAS, this fund will enable the City to leverage additional state, federal, and private resources, helping to close financing gaps and accelerate the delivery of critical housing services; and

WHEREAS, investing in affordable housing strengthens neighborhoods, reduces homelessness, improves economic mobility, and promotes equitable access to opportunity for all Albuquerque residents.]

3. Beginning on page 2, line 6, amend SECTION 1 as follows:

SECTION 1. Name. This municipal gross receipts tax shall be known as the "[Quality of Life Enhancement] [Affordable Housing] Fund."

4. On page 2, line 28, through page 3, line 24, strike SECTION 5 in its entirety and replace with the following:

[SECTION 5. Dedication. All revenue from the municipal gross receipts tax will be deposited into an Affordable Housing Fund and shall be used for the City's Affordable Housing Goal Priorities, as determined by the City Council.]

#### **EXPLANATION:**

This amendment proposes to dedicate the GRT revenue generated by this tax to the City's affordable housing goal priorities.

This amendment includes a title change, so publication of the new title will be required prior to final action on the bill.

If this amendment is approved by the Council, a corresponding amendment to R-127, the companion ballot resolution, will be required.
