New Mexico has one of the highest rates of youth homelessness in the nation, yet currently lacks sufficient shelter options tailored to the unique needs of young adults transitioning into independence.

Transitioned-aged youth experiencing homelessness face elevated risks of substance use, victimization, and long-term housing instability, making dedicated housing and treatment resources critical for prevention and early intervention.

The proposed Young Adult Housing and Treatment Navigation Center will provide 41 shelter beds, case management, and individualized support services designed to

stabilize vulnerable youth and help them transition toward permanent housing and selfsufficiency.

The Young Adult Housing and Treatment Navigation Center is expected to serve an estimated 164 individuals annually.

Funding for the Young Adult Housing and Treatment Navigation Center and Opportunity Youth Reengagement Pilot Program is intended as startup or seed funding to launch programs and represent a one-time investment to initiate services that will pursue longterm sustainability through other funding sources
