1. Amend SECTION 2, beginning on page 2, line 11, as follows:

SECTION 2. USE OF FUNDS.

A. The funds appropriated in Section 1 of this bill are to be used for acquisition, renovation, or expansion of transitional recovery [temporary] housing [shelters] [facilities] as well as providing transitional recovery housing vouchers attached to the units and/or for operational funding to support a project-based recovery housing campus and solicitation for an operator of the transitional recovery housing project.

[B. The transitional recovery housing project funded by this bill shall be located in City Council District 2 or within 0.5 miles of the boundaries of City Council District 2.]

Explanation:

The amendments to Paragraph A clarify that the funding for housing appropriated in this resolution is for the purpose of funding temporary recovery housing shelters. The intent of this Resolution is to appropriate funding for a temporary housing project made from small, temporary, single or double occupancy shelters. The site would include hygiene units and space for dining and wrap-around services.

Paragraph B specifies that the transitional recovery housing project funded by this bill shall be located in City Council District 2.
