1. Beginning on page 1, line 3, amend the title as follows:

**DIRECTING THE CITY ADMINISTRATION TO UTILIZE STATE CAPITAL
OUTLAY FUNDING ASSOCIATED WITH [~~PROJECT NO. 24-I2735 AND~~] PROJECT
NO. 24-I2699 FOR THE COTTAGES AT 161 CHAMA AFFORDABLE HOUSING
DEVELOPMENT AND TO FACILITATE THE DETERMINATION THAT
STREETVISION HOUSING STRATEGIES IS A QUALIFYING GRANTEE.**

2. On page 1, beginning with line 8, amend the WHEREAS clause as follows:

**WHEREAS, during the 2024 Legislative Session, the State of New Mexico
appropriated [~~Two Hundred Seventy-Five Thousand Dollars (\$275,000) to acquire
land for and to plan, design and construct affordable housing for underserved
communities in Albuquerque in Bernalillo county through State Capital Outlay
Project No. 24-I2735, entitled "ALB EQUITABLE HSING CONSTRUCT," and]~~
Seven Hundred and Eighty Thousand dollars (\$780,000) to...**

3. On page 1, line 21, amend the WHEREAS clause as follows:

WHEREAS, the City of Albuquerque accepted the appropriations and entered into agreements with the New Mexico Department of Finance and Administration for the administration of ~~[Project No. 24-12735 and]~~ Project No. 24-12699;

4. On page 2, line 9, amend the WHEREAS clause as follows:

WHEREAS, the City Council finds that utilizing ~~[Project No. 24-12735 and]~~ Project No. 24-12699 for the Cottages at 161 Chama advances the original legislative purpose of increasing the supply of affordable housing within Albuquerque;

5. On page 2, beginning on line 30, amend Section 1 as follows:

**SECTION 1. ~~[\$275,000 (Two Hundred and Seventy-Five Thousand dollars)]~~
~~[\$350,000 (Three-hundred and Fifty Thousand dollars)]~~ identified in 2024 State
Capital Outlay grant ~~[24-12735 and \$75,000 (Seventy-Five Thousand dollars)~~
~~identified in 2024 State Capital Outlay grant]~~ 24-12699 is hereby re-appropriated to
the following affordable housing project located...**

EXPLANATION: This amendment proposes to remove 2024 State Capital Outlay grant 24-12735 from the re-appropriation and places the full amount (\$350,000) of the funds to be re-appropriated from grant 24-12699.
