oning 0-18-2 | Amending Chapter 14, Article 5, Part 2, ROA 1994, The Drainage Ordinance, To Implement Best Practices For The Management Of New Runoff Associated With Land Development (Jones)

@ LUPZ on August 15th

Revisions to this ordinance propose compliance measures to ensure that new development and certain redevelopments have practices in place to promote minimum stormwater quality standards for stormwater leaving their individual sites in order to meet EPA requirements and help preserve water quality in the Rio Grande River.

O-18-21 | Amending The Uniform Housing Code, Sections 14-3-1-1 Through 14-3-5-99 ROA 1994, Relating To Minimum Dwelling Safety And Sanitation Standards, Identification Of Hazardous Dwelling Conditions, Nuisance Abatement, Administration And Enforcement (Gibson)

This ordinance proposes to add a registration system for residential units being utilized as rental properties. It adds various definitions and provisions related to rental properties and also sets forth a penalty system for properties who do not register or do not meet the requirements of the registration process.

R-18-40 | Establishing City Policy For The Implementation Of Downtown Walkability Improvements; Repealing And Replacing R-15-152 (Enactment R-2015-024) (Benton)

This resolution restates the intent of the Downtown Walkability Study the City had contracted in 2014 and more firmly directs the Department of Municipal Development to implement the recommendations in the report. It also specifically calls for the resinstatement of two four-way stops at downtown intersections that were recently reverted to traffic lights.

TorC's brewery success spurs talk of liquor law remix, published by

"Local beer and live music helped revive downtown Truth or Consequences. Now state lawmakers are wondering if similar ingredients can help Main Streets in smaller cities across New Mexico.

Members of a legislative committee agreed this summer to take a look at New Mexico's complex system of liquor licenses, along with other ideas to help downtowns, with an eye on proposing changes in the 2019 session. They highlighted the Truth or Consequences Brewing Co. as an example of the power of offering visitors an "Oasis Ale" or "Hot Springs Lager" – local beers on tap in TorC."

"As the country continues its long recovery from recession, there are signs that a much deeper shift is happening at a local level, the seeds of which were sown years ago.

Indicators far more subtle than job numbers suggest a flourishing of entrepreneurship, collaboration and problemsolving, away from the gaze of national media.

After five years spent visiting dozens of towns, The Atlantic writer James Fallows and his wife Deborah have written a book Our Towns which paints a portrait of renewal, a story at odds with the well-documented gridlock of higher levels of government.

Fallows says that in several areas - civic engagement, returning talent, growth of tech start-ups, downtown revitalisation, an openness to immigrants and thriving libraries - local America seems to be flourishing."
