RESOLUTION

2 TO INDEPENDENTLY INITIATING A PROCESS REVIEW THE CITY'S MECHANISMS OF POLICE OVERSIGHT; CREATING AN AD HOC POLICE 3 OVERSIGHT TASK FORCE TO OVERSEE THAT PROCESS AND MAKE 4 **RECOMMENDATIONS TO THE CITY COUNCIL; CALLING FOR THREE PUBLIC** 5 FORUMS TO BE HELD AT VARIOUS LOCATIONS THROUGHOUT THE CITY. 6

WHEREAS, the City of Albuquerque maintains a highly professional well 7 trained police department; however, an effective oversight mechanism is 8 9 critical to maintaining the public's confidence in that department; and

WHEREAS, the City Council has enacted a Police Oversight Ordinance to $[+B_{1}^{10}]$ ackę₁ provide oversight of the Albuquerque Police Department and oversee all citizen ted/ complaints; and Und²

WHEREAS, recent events have eroded the public's faith in that police oversight process and the City Council feels that the process needs to be reevaluated and changed if necessary; and

WHEREAS, the Police Oversight ordinance requires periodic evaluations so as to "undertake a complete evaluation and analysis of the entire Police Oversight Process, and recommend any necessary changes or amendments that would appropriately improve the process." §9-4-1-11 ROA 1994; and

WHEREAS, the City Council believes that the creation of a Police Oversight Task Force is an appropriate first step in bringing expertise to bear on the review of the police oversight process; and

WHEREAS, as an indispensable part of that review process, the City Council finds it necessary to hold public forums to receive public comment on the existing oversight process, and suggestions on ways that it can be approved, from the citizens of Albuquerque; and

The Task Force shall +]meet as many times as necessary so as to complete a thorough evaluation and New⁴ analysis of the police oversight process and report back to the City Council [-B²⁵ acke₆ with its recommendations for improving the police oversight process by the ted/ end of December 2013. The Task Force shall review the history and evolution Strik⁷ eth_{f8} of the existing police oversight system by reviewing the results and oug h-²⁹ recommendations of the Walker/Luna study and both the 2006 and 2011 MGT Mat₀ studies. The Task Force shall receive briefings and presentations, as erial necessary, from subject matter experts on the city's current oversight system, -1-31 Dele₂ and on best practices and oversight models from other cities. The Task Force **-**:---may request the City to engage nationally known experts in the field of police 33

1 1 oversight to assist them in making their recommendations. Staffing for the 2 Task Force shall be provided by the City. Section 3.
