Bernalillo County Behavioral Health Crisis Services Committee Meeting Minutes

June 29, 2016

I. Call to order

Committee Chair, Rick Miera called to order the regular meeting of the Crisis Services Committee at 2:05 p.m. on June 29, 2016 at The Indian Pueblo Cultural Center.

II. Introductions

- Need to be sure to be inclusive of Native American population and have representation during discussions; continued cultural competence throughout all projects.
- Consider youth needs and impact related to proposed projects; acknowledge differences in statute related to youth vs. adults in the criminal justice system.
- Consider developmentally disabled and individuals with TBI
- Consider when policies are related to State/Federal statute vs. department based statute

V. Overview of committee role and process

Committee staffer, Margarita briefly discussed committee role and process. Committee members will be brought projects proposals recommended by existing reports that are specifically related to crisis services to committee. The committee will then have the opportunity to vet these proposals. The committee will vet the proposed intervention, target population, evidence base, proposed outcome metrics and budget (among other items if needed). Committees will strive for consensus on each proposal before providing an official recommendation to the steering committee or ABCGC.
