On August 16, 2010, the City Council passed R-10-109, which creates the Charter required Redistricting Committee. That Committee's purpose is to make recommendations to the Council regarding redistricting the council districts based on 2010 census data.

The Charter requires that the Redistricting Committee be composed of an equal number of members from each Council district, must "as nearly as practicable" provide fair and balanced representation of the entire City, and its membership must "reflect the racial, ethnic and gender makeup of the City's population";

On August 27, 2010 and again on September 8, 2010, the City Council held study sessions to discuss the proposed makeup of the Redistricting Committee. The names listed below are those proposed by each Council member, and we believe that a Redistricting Committee comprised of these members represents, as nearly as practicable, the geographic, ethnic and gender makeup of the City of Albuquerque.

As such, we respectfully request your approval of the appointment of the following individuals to the city's 2010 Redistricting Committee:
