Second Hand Dealer Application And Second Hand Dealer Renewal Application

It is the responsibility of the Applicant to complete the following Steps to order to obtain a City of Albuquerque Second Hand Dealer Permit

1. Zoning Enforcement:

- a. Signature and approval from Zoning on initial application /
 Renewals will just have to check renewal box on application.
- **b.** Zoning will return application to applicant.

2. Police Department:

- a. Signature and approval from APD.
- **b.** APD will return application to applicant.

3. Treasury Division:

a. Take completed application with signatures and approval from the appropriate departments to Treasury Division (City Hall Room 1080B) and pay the fee (*To be determined*).
