- 1. Why is there no diagram in the uniform traffic incident report (see 2-46-4-A-2)? It could be that the diagram is missing or was redacted from our copy only, in which case it'd be useful to see it. If there actually wasn't a diagram prepared we would like to know why. (note: I vaguely remember the Board having been told in the past that it is not typical to complete a diagram for "minor" incidents, but the SOP doesn't seem to allow that exception and given the circumstances I would question calling this "minor." If this is a situation where field division is following orders different from the adopted SOP we really need to get that sorted out)
 - 1a. There IS an accident diagram (obtained). On 12/1/2021, Per Traffic Sgt. Christopher Rody: As far as diagrams not showing up on the report, there is a glitch on the Record Department's end and said sometimes when records are requested, diagrams will not always show up.
- 2. How exactly did the responding officers make the decision to close the investigation of a possible battery (2-60)? Why was no further investigation or follow-up performed? Given the matrix in 2-60-3-E, should the matter have been assigned to a detective? (note: Jayawardana obtained surveillance video that helps to clarify events, did APD try to find footage that might show any assault/battery that occurred?)
 - 2a. This was documented in the investigation study: As far as an effect for an arrest regarding the alleged physical assault, Officer Lopez said it was a misdemeanor battery outside of their presence so they don't usually arrest. She also said there were conflicting stories so they don't know if it was true or not. Officer Lopez said there were a lot of witnesses that said it didn't happen (granted they were with Pacheco). There was nothing to indicate that it did happen. And even if it did, they wouldn't have arrested on scene and would have either summonsed or made a report because they don't always arrest for battery outside of their presence. Lt. Weidner was then asked about the alleged assault and why Pacheco wasn't arrested; he said if it did happen, then it's considered a misdemeanor outside an officer's presence, which is not an arrestable offense. Lt. Weidner said Pacheco could have been summonsed if the officers felt that they had established probable cause.
- 3. While APD does not formally determine fault in traffic accidents, the uniform traffic incident report in this case strongly suggests the complainant was at fault by noting "inattentive driving" on his part and "no driver error" on the part of the motorcyclist. How did the responding officers reach these conclusions? Is it typical to put as strong of language as "no driver error" in a traffic incident report? (2-46)
 - 3a. Officer Lopez said the report is accurate and that nothing should be changed as it is based on facts and observations. At no time did Jayawardana's car appear to be turning right as Jayawardana adamantly reported; video and still shots show Jayawardana was going straight while driving in the bike lane. Jayawardana was unable to tell the difference between turning right and going straight, as evidenced by

his own video he provided during the investigation. Jayawardana was not forthcoming when it came to the direction he was driving and argued that the report was a lie. Officer Lopez said both parties could have been cited for being in the bike lane. Officer Lopez said when it comes to writing up the report, they don't indicate or determine who's at fault and just list the facts; she said ultimately, it is up to the insurance companies to make those determinations.

- 4. Did someone on scene admit to having punched the complainant to Lt. W? Was this investigated further? (note: this came up as a question during our deliberation, but reviewing the investigator's report this morning it seems like Lt. W's OBRD was reviewed a couple of times to check for such an admission and it wasn't there. Still, to comply with the motion an investigator should address this, and I think it would be productive to look into how this relates to #6)
 - 4a. This was documented on the report and was investigated as Lt. Weidner agreed that Officer Lopez and Officer Morrow came to him so they could review his lapel to see if Pacheco actually admitted to assaulting the complainant; per Lt. Weidner, they were unable to find any evidence of such a direct admission. Officer Morrow also said they did not have probable cause to issue a summons or effect an arrest on Pacheco because Jayawardana was unsure of who hit him. At that point, they only had reasonable suspicion and she supported that by observing the small cut on his nose. And even with unsure testimony from the complainant, the officers did their due diligence as they went to their lieutenant to review the lapel to see if Pacheco himself admitted to punching Jayawardana.
- 5. A bystander apparently called 911 to report the situation. Did APD attempt to interview this witness? why/why not? (note: I think this is Amber Coolidge who the Agency did speak to, but the way the investigator's report is written it's not clear to me if the citizen 911 caller and Amber Coolidge are the same person).
 - 5a. As the accident was unfolding, the officers onscene would not have been aware of the anonymous witness unless an operator/dispatch told them to reach out. After lapel review, dispatch/operators never made that call to the responding officers. The CPOA Investigator did interview the witness as documented in the report, albeit, brief. She was asked if she saw the complainant get physically assaulted by Pacheco or anyone else and she said she did not see anything.

On her recording with 911, the citizen was asked if she witnessed anything transpire before the yelling and she said no. She said she didn't believe there were injuries and did not mention any punches thrown. Also, there was no mention of racial slurs on the recording. And as captured on the audio recording, the operator asked the citizen if she wanted to meet with the officers and she said no and did not want to be identified by the gang.

- 6. From the information the Board received it appears that APD officers spoke to the motorcyclists "en masse," including when asking questions about the alleged battery. Why didn't officers separate the motorcyclists to get independent information? (2-60)
 - 6a. Yes, they could have been interviewed individually, however, what is clear is the motorcyclists are a collective group of friends, (therefore there's an assumption they're going to be biased). However, even if they were interviewed individually and provided varying testimony, that is just part of the investigative process. And the other parts of the investigative process include, but are not limited to, reviewing camera, lapels, listening to audio, photos, emails, documents, etc., all of which contribute to the totality of the investigative decision. A preponderance of the evidence is what our investigations are based upon.
- 7. The officers on scene seemed very friendly/genial towards the motorcyclists but not towards the complainant. This was described as an effort to build rapport. Why wasn't this same effort made towards the complainant? This greatly contributes to the feeling of racial or other bias (1-1-5-A-2).
 - 7a. This was not reported by Jayawardana, however, Officer Lopez mentioned all the witnesses, were collectively biased based on friendship/motorcycles. According to Officer Lopez, the motorcyclists said they did not witness Pacheco punch Jayawardana.

The reason why it "appeared the officers were very friendly/genial towards the motorcyclists but not towards the complainant" was because it was observed that Jayawardana had his lady friend constantly intervening and trying to disrupt the officers' investigation. The lady friend was warned at least 2-3 occasions to stop trying to intervene in the investigation and questioning process as it appeared she may have been trying to coach the complainant and/or give him answers. "She was interfering with our investigation. We had to stop her; she wasn't there for the crash and she did not witness it." Again, this was documented on the investigative study.

The focus should not be on "being friendly as an effort to build rapport". The focus is impartiality and on obtaining facts based on evidences and testimonies.

- Facilitates ESU assigning SUAS to area commands and then monitoring use, rather than directly deploying SUAS. Based on log sheets.
- 2-15-4-D-3 needs clarification of "and" or "or", and if "or" 2-15-4-D-3-a is so broad as to make 2-15-4-D-3 far less useful.





Force cases are now categorized by three levels. If a case involves multiple applications of force, it is categorized as the most serious at the case level. These counts are not considered final as investigations are continuously updated.


- Level 1 is force that is likely to cause only transitory pain, disorientation, or discomfort during its application as a means of gaining compliance. This includes techniques which are not reasonably expected to cause injury, do not result in actual injury, and are not likely to result in a complaint of injury (i.e., pain compliance techniques and resisted handcuffing). Pointing a firearm, beanbag shotgun, or 40 millimeter launcher at a subject, or using an ECW to "paint" a subject with the laser sight, as a show of force are reportable as Level 1 force. Level 1 force does not include interaction meant to guide, assist, or control a subject who is offering minimal resistance.
- Level 2 is force that causes injury, could reasonably be expected to cause injury, or results in a complaint of injury. Level 2 force includes use of an ECW, including where an ECW is fired at a subject but misses; use of a beanbag shotgun or 40 millimeter launcher, including where it is fired at a subject but misses; OC Spray application; empty hand techniques (i.e., strikes, kicks, takedowns, distraction techniques, or leg sweeps); and strikes with impact weapons, except strikes to the head, neck, or throat, which would be considered a Level 3 use of force.
- Level 3 is force that results in, or could reasonably result in, serious physical injury, hospitalization, or death. Level 3 force includes all lethal force; critical
 firearms discharges; all head, neck, and throat strikes with an object; neck holds; canine bites; three or more uses of an ECW on an individual during a
 single interaction regardless of mode or duration or an ECW application for longer than 15 seconds, whether continuous or consecutive; four or more
 strikes with a baton; any strike, blow, kick, ECW application, or similar use of force against a handcuffed subject; and uses of force resulting in a loss of
 consciousness.



Call Types Associated with October 2022 Force Events



Executive Director Report—September 8, 2022 Board Meeting

- I. Since the September 8, 2022 meeting, CPOA has received:
 - a. 19 complaints
 - b. 16 driving complaints
 - c. 8 commendations
 - d. 28 cases on agenda
- II. The average case load I gave the Board last month was calculated by asking each of the investigators how many open cases they had at that time and calculating an average from that.
- III. We asked APD about getting us a hard copy of the SOPs and were told that that won't be logistically possible. APD is, however, willing to provide the Board with training on the use of PowerDMS, if the Board is interested.
- IV. IMR-16 was published yesterday. I'm still going through the report, but we have already started implementing additional discussion of credibility assessments where necessary, which were one of the primary criticisms of the cases held to be out of compliance when we reviewed the draft. The hearing on the report will be all day on December 6.
