Director Harness replied that if the evidence in the investigation pointed toward the chief, the chief would have been interviewed. Mr. Jim Larson withdrew his public recommendation that the case be audited. Member Fine concluded that the Case Review board is on notice and suggested that an assessment of nonconcurrence cases be part of the semiannual report. |

- a) Mediation Program update. Motion for the mediation program was drafted and is with the DOJ to be reviewed for filing. Director Harness will follow up with Attorney Riles to see if he can get a timeline.
- b) Data Analysis Contract. Director Harness had a conference call with Attorney Schmehl, Major Tyler, and Procurement Attorney Bradley on Friday regarding reservations about data analyst contract. They wanted to limit data access and director Harness inquired to Attorney Bradley why anyone outside of APD has the right to limit information from APD. If Director Harness does not hear from Attorney Bradley by Thursday, Director Harness will have Attorney Bleaker or Jackson address it.
- c) Conference. Investigators Skotchdopole and Davidson attended the Daigle Law Group Use of Force Summit in Connecticut and found it was well worth going to that training.
- d) Update on cases to review. Regarding the forced review cases from Nov 17, Member Fine suggested they attempt to be done by March—take the first third of cases in January, the second third in February, and the third third in March.
