 - **A. CPC 251-15:** CPOA Investigator Diane McDermott discussed the appeal request in CPC 251-15.
 - i. The complainant stated in his original complaint that he observed a police officer in full uniform at District Court and alleged that the officer was in violation of several SOP's regarding wearing his uniform at a court proceeding and was not wearing his lapel camera. The CPOA's findings of CPC 013-16 for Major G. are:
 - 1. **Exonerated** for violation of SOP concerning officers appearing or testifying in Court and wearing their uniform;
 - 2. **Not Sustained** for violation of SOP concerning uniformed officers wearing lapel camera while on duty.
 - **ii.** Members discussed the issues of the appeal and have decided to go ahead and grant Mr. Arasim's request for an appeal hearing and that his request be placed on the next POB meeting agenda.
 - iii. Subcommittee Member Fine made a motion that we suggest to the POB that Mr. Arasim have an opportunity to visit with us about his appeal of this decision so that we may have a discussion with him about it. Chair Waites seconded the motion. **Approved.** For: Fine, Waites
