My name is [REDACTED] and I am the reporting party for the medical call in question. I am a licensed EMS provider in the state of New Mexico, certified at the First Responder level. I am also an active member of the Bosque School Medical Reserve Corps/Emergency Response Team (MRC/ERT). While we operate as an official EMS agency, all of our responders, including myself, are high school students. The majority of calls we handle are typically non-life-threatening.

I was the first person on the scene and called 911 to report the incident. Shortly after, police units arrived, and I met the first two officers on scene, Ofc. Fernandez and Eric. Both officers were incredibly kind, compassionate, and supportive, helping to calm me down from the initial stress of encountering a man down. Their presence allowed me to focus and let my training fully engage as I provided care until I could transfer the patient to Albuquerque Fire Rescue (AFR).

What Outcome are you Seeking?

The outcome I am seeking is to share the kind words with the 2 officers mentioned above and the applicable Coc staff.

They showed me so much kindness to be left unrecognized.

Dear APD Command Staff,

On January 13th, 2025, in the Southeast Area Command, a domestic violence call came out about a barricaded subject in the residence near the intersection of Buena Ventura and Glorieta. The perimeter was 1.5 square mile radius around the neighborhood.

It created a lot of issues for residents to get back to their homes and to compound the issue, it was snowing pretty heavily. I was videoing the scene just north of Central Ave on Glorieta St. I encountered Police Service Aide Alan Mena holding a perimeter.

During my time at the scene, there were two separate elderly individuals who came to the perimeter spot and needed to get to their home in the extreme cold and snow.

PSA Mena radioed to his supervisors to see if the two individuals could get to their homes. It was determined that their homes were far enough away from the scene they could safely return home.

PSA Mena was observant in seeing the two elderly people needed assistance and was able to resolve the problem efficiently with the community members.

PSA Mena is a bright spot in the Albuquerque Police Department and showed he was "In Step with the Community."

I recently flew Alaska Airlines to the Albuquerque International Sunport (5/31/25). Upon arrival and picking up my luggage at baggage claim, I discovered that one of my three bags was badly damaged. After speaking with an Alaska representative, I was told that the airline would reimburse me for a new replacement bag; however, I first had to buy the bag and bring the receipt back to the airport and show it to an Alaska airline supervisor. While this seems like a simple solution, it was problematic for me because my flight arrived at 12:00 AM and the check in time for my connecting flight was 10:00 AM the same morning.

With a 10:00 AM check in to leave Albuquerque the very same morning, here's a few of my issues:

(A) It was the middle of the night and all of the major department stores were closed.

(B) I had three pieces of luggage that I had to keep track of (one of them being seriously damaged, heavy, and difficult to handle).

(C) I had no personal means of transportation.

(D) And, whatever I decided to do, I had a small window of time to do it before my next flight.

After spending two hours talking to airport staff and representatives of Alaska and United airlines, I wasn't able

to come up with a truly viable plan.

But while sitting alone in the airport at around 2:15 AM, Officer Greg Valentino happened to walk past me on his rounds. As he walked past me, I asked him if I could ask him a question? Officer Valentino stopped and asked me what did I need? I won't try to recount our entire conversation, but over the next 20 minutes he listened to me and grasped my predicament. He took time to go on the internet to try to see if there was a way to get a bag purchased and delivered to the airport. Believe it or not, there was a way to get a bag delivered, but not within my time window. Even though the internet search was not successful, I really appreciated Officer Valentino taking the time to do it because I did not have a cell phone.

So, after spending about 20 minutes trying to help me, I was ready to give up and thank him for his efforts so that he could continue with his rounds. But, OUT OF NOWHERE, Officer Valentino explained that his shift would be over in 3 hours and that if his Supervisor Delores Sanchez approved it, he would drive me to a Walmart to purchase a bag and then bring me back to the airport on his own time. I COULDN'T BELIEVE IT! I WAS JUST SOME STRANGE GUY PASSING THROUGH ALBUQUERQUE, BUT HE WAS WILLING TO HELP ME AFTER HIS SHIFT WAS OVER ON HIS OWN TIME.

About three hours later when his shift was over, Officer Valentino took me to a store where I purchased a replacement bag. Then he dropped me off back at the Sunport and Alaska reimbursed me on the spot! While this story may seem small and trivial to many, the actions of Officer Valentino were huge to me. As someone who has often faced racial discrimination, my interaction with Officer Valentino was one of the best professional encounters I have ever had with law enforcement. Thus, I would just like to acknowledge the professionalism and humanity of both, Greg Valentino and Delores Sanchez. AGAIN, MY SINCERE THANKS!
