

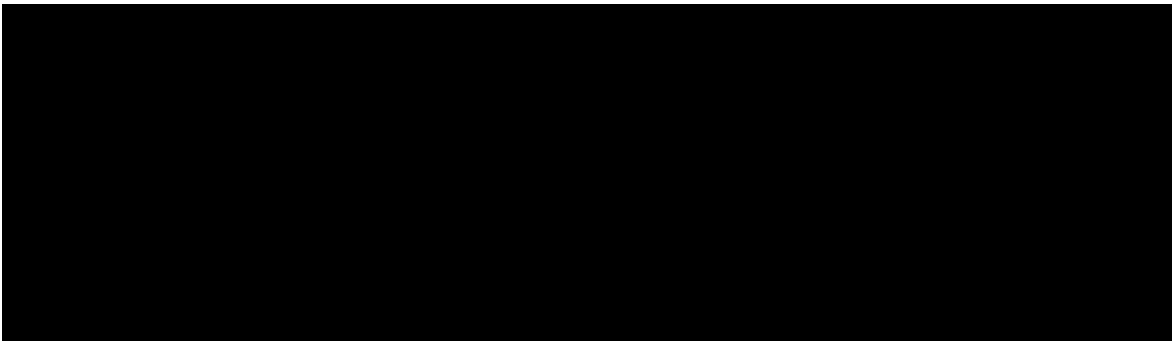

I walk on Broadway between Claremont and Menaul everyday--and it is usually terrifying. Traffic is always going too fast for the curve (as the tire marks on the sidewalk indicate). But today, an officer in Unit P21 made what I believe to be a traffic stop. It's the only time in my 8 years of this walk to see a traffic stop. While the officer's unit was in the parking lot at that corner, traffic was moving at legal speeds. I have complained about this area of Broadway in the past--and we have had multiple (often serious) traffic accidents along that section. We've had very close calls--as when one person lost control on the curve and flew through a neighbor's yard (where he narrowly missed two people) and into a brick wall. This officer's action today just demonstrates what traffic control can do--even when it's just a simple traffic stop. Thanks to the officer. It is the first traffic-related stop I've seen in Albuquerque in the 10 years I've been here.

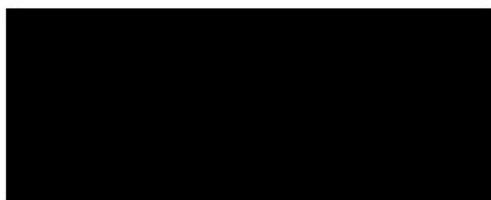
What happened? I was born in Albuquerque, New Mexico in 1979. It was such a cute, close, little city. Everyone knew someone or knew their family. The city was well maintained. Public places were well maintained, streets aligned with flower beds. I moved away when I was 21. Albuquerque hasn't improved at all since I moved away. The city looks run down, unsafe, and unwelcoming. The homeless camps are overwhelming. I no longer feel safe when traveling there.

In 2018 my baby sister was murdered. [REDACTED] was 27 years young!

Unfortunately for my family and I she was just another number. Albuquerque has gone so down hill. We have also noticed people don't stay in their office position for long. I am sure you have noticed how inconsistent city officials are. We have gone through so many different District Attorney's. We have also had quite a few victims advocates. It seems like nobody cares and nobody is held accountable. Luckily for my family, one person has remained loyal, empathetic, and available is Jesse Carter. Detective Carter kept us updated and answered any and all of our questions when nobody else could. I know my family could not have gotten this far without Detective Carter's determination, dedication, and drive. He is a hard working officer and we are so incredibly blessed he took my sisters case. Albuquerque needs more officers like Detective Jesse Carter!

This is a intriguing case considering all the details. Hilarie was a well known artist and on several billboards throughout Albuquerque and she was also on a few city busses. My baby sister loved everyone unconditionally. She was very well liked and known in the city. Unfortunately, Hilarie could not see evil if it were looking directly at her. Hilarie was shot in the middle of the day over pitiful \$40.00! Yet the district attorney's office dropped the ball, made several mistakes, and released a killer into the community. The district attorney's office did not do their due diligence in this particular case. My sisters murderer has been arrested over 30 times, does not respect the law, and had to be extradited twice from California! Detective Carter's elaborate training and will power has given my family security, peace, and some satisfaction. I hope and pray that you can continue to follow Jesse Carter's lead.

Moving forward in my opinion there needs to be a cultural change in Albuquerque with the lack of respect towards Albuquerque police. They protect us against the same, repeat offenders who are never held accountable for their actions.

To whom this may concern,

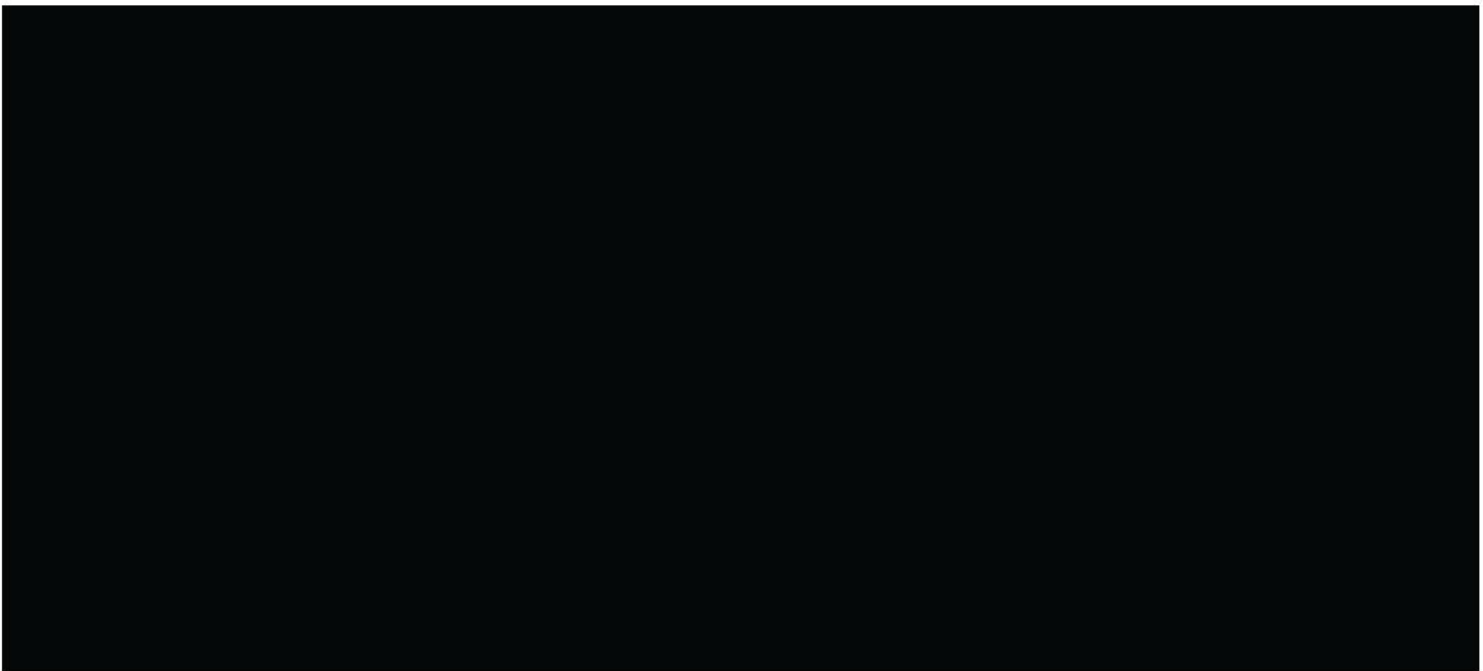

I explained that the police officers told her dad to stay away and that because of the police officers, we have not seen him around our home. She does believe me that the officers told him. I was hoping that maybe an officer, if they had time during the weekend was able to come to our home and let her know she is safe.

I know it's a lot to ask, and I understand your officers are busy.

Either way, thank you so much. I pray that each one of you are kept safe, know that you are loved. And a few of us understand the sacrifice your doing, regardless if you don't see it... I truly feel that because your officers got involved my 5 year old and I are safe. Please continue doing what your doing. Thank you.



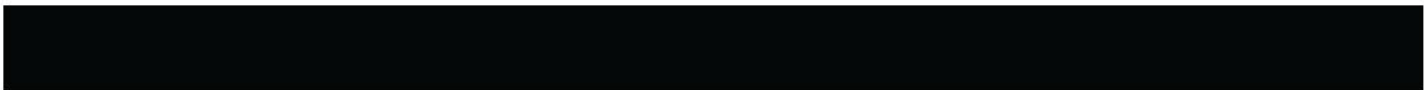

It really gives us a bad reputation in our communities-- and also it probably encourages those that would do us harm. The term "spa" or "business" is much more appropriate. I'm trying to educate the public and would appreciate your help.

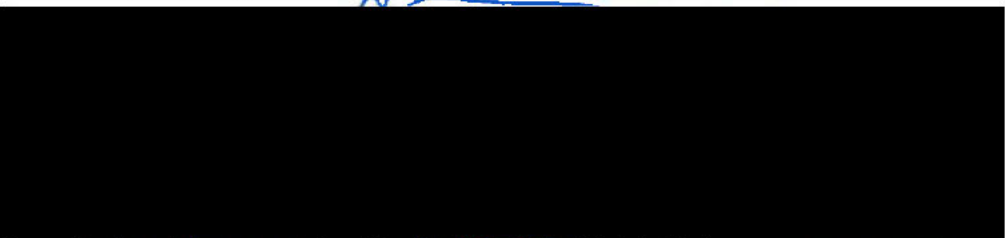

I will be eternally grateful for these officers actions, to APD for the training you have given them, and the fact that I'm sitting outside watching the sun come up over the sandias.

There could have been a much different, tragic end to this situation were it not for the way these men reacted to my crisis. So, from the deepest place inside of me, thank you. I'm so very grateful to these men and to APD. You have a friend and supporter for life.
