Sergeant Fox conversation

I am submitting a letter of commendation to Sergeant Fox regarding an educational conversation we had on the scene of a homicide which occurred on June 23, 2023 at around 11:45AM.


I want to point out the educational conversation I had between Sergeant Fox, an unknown patrol officer and my business partner Nick Layman about our ability to be an onlooker, provided by APD's own decades-long never changed or amended policy providing rights of onlookers policy(2-33). On June 23, 2023 I was flying my drone gathering aerial footage in FAA airspace above Stardust Skies Park which was the scene of a homicide. There are strict FAA guidelines prohibiting ANYONE from interfering with a pilot while in command of any aircraft. Sergeant Fox and the unknown officer waited for me to land our company owned drone and we had a conversation at the back of our company Tahoe.

This conversation was cordial and it was conveyed that if Sergeant Fox or anyone from his homicide crew had an issue with my drone that they would contact me directly and have a civil conversation about what they felt was the issue.

All officers and supervisors department wide must be educated as to the rights of onlookers and rights of licensed pilots flying drones. Not knowing how to handle pilots legally flying in FAA airspace greatly places the department in danger of litigation and scrutiny from the federal government.

Videos of the encounter will be provided if needed.




What Outcome are you Seeking?





I am an RN at UNMH in the Trauma/Surgical ICU. On the night in question, although I cannot remember the specific night it was sometime in December, Sgt Bobby was watching my patient who was in custody following a shoot out with police. My patient was very aggressive and abusive to me, verbally harassing me while I tried to set up his life saving drips and provide care. Your officer noticed me becoming upset, and took his job a step farther than most when he entered my room, stood on the opposite side of the room from me, and respectfully redirected my patient. He spoke to him as an equal, getting him talking about his life before he got arrested, what led to the incident, and plans he might want to make for after his sentence. I felt very safe knowing that he was in the room. I also was thankful that I was able to finish providing the cares I needed for my job without facing the harassment that I had been prior. I was very impressed at this officer's patience with my patient; never did he show signs of frustration or anger. I have been a nurse on my unit for over 2 years, and we see a lot of patients in custody. Never have I had the pleasure of working with an officer who I felt so strongly was there to support me and protect me. It's taken me some time to submit this form (procrastination is my weakness) but I think about this man often and appreciate his strong, honest, compassionate work.


What Outcome are you Seeking?

The fact that this PSA took time out of his day to be personable with a total stranger and his dog is very much commendable and must be recognized.



- trying to enter the church where the congregation was attending mass (congregation consisted of a lot of children and elderly persons)
- threatening to strike a parishioner with a large rock and to take someone's jewelry
- displaying behavior consistent with substance abuse and/or mental health issues, ie talking in other languages, not standing still, walking back and forth, not willing to explain why he was there or what he wanted with the church, wanting to fight parishioners, throwing items around and wanting parishioners to pick them up, etc.

Several parishioners, including were there to deny David access to the church to protect the other parishioners from David's antics. I arrived just after the initial encounter with David and Dominic. I tried to speak with David however, he did not want to hear what any of us said. David had an agenda that only he knew. This was apparent when I displayed my police badge and David said, "I don't care about that badge," and continued on without hesitation.

David started escalating and getting more confrontational with Dominic, by ridiculing him and wanting Dominic to pass on a note to someone. When Dominic refused, David started counting. We took it that if Dominic did not comply by the time he

was done counting David was going to fight Dominic.

At approximately this time, I called the APD Dispatch to request officers. I identified myself as a police officer and explained the situation and that I was concerned about this incident escalating to a situation where a firearm needed to be drawn and used in self-defense. The dispatcher was able to create a call and finally dispatched APD Officers, including Ofc. S. Casillas #7866 and another officer who I believed was on OJT with his FTO. I did not get their names.


When the officers arrived on the scene, they were very professional and took over the scene seamlessly. They interviewed Dominic who was the first person to interact with David. They were able to use their CIT and de-escalation skills to calmly speak with David to further their investigation. They escorted David off the premises and to the sidewalk near their police units without violence or force. It was reassuring to see officers taking their time to complete a full investigation. I have seen so many officers, even in my own agency, that downplay these types of calls and rush them just to move on to the next call. I would be confident that if something happened in the future and these same officers responded, they would respond appropriately and effectively. The congregation was relieved and grateful for the prompt police response.

In the end, Ofc. S. Casillas issued David a Criminal Trespass Notification and sent David on his way without incident. Officers remained on the scene until David vacated the area. Ofc. S. Casillas provided the church with a copy of the CT Notification along with a case number. She even stated what time she was off duty in case David returned during her shift. What Outcome are you Seeking?

I want the officers to receive a commendation or job well done for their hard work. This commendation or citation should be one that they could place in their professional records. Their timely response prevented this situation from getting much worse. These officers need to know their hard work matters and the congregation of St. George notices their hard work.

We called the non-emergent line to ask where we could report a sexual assault as the Osuna substation was closed for the weekend. The dispatcher sent an officer to our location and that was Officer Ketchum. He listened and took my report, he was very gentle, he encouraged me to press charges without being pushy or aggressive, and he made sure to tell me where I needed to go to have the exam done. He encouraged me to call as soon as possible so the evidence could be preserved, he also made sure to tell me how to store the evidence I had in my possession so when I gave it to the nurse at SANE it wouldn't be contaminated.

Reporting a sexual assault is already an incredibly difficult thing to do, but he handled it very well and at the end of it I felt like I'd be heard and cared about. This isn't my first experience with law enforcement as a victim, but it was my first with APD, and the difference was startling. I appreciate his kindness and gentleness in dealing with something that is already horrific.

Also, when I was speaking with the advocate at SANE and told them which officer had taken my report they were also happy to hear it had been Officer Ketchum. He's very good with victims and that's something that is super important in law enforcement.


What Outcome are you Seeking?


