

Hello.

I was given you guys as a resource to send over a message of gratitude to one of the APD officers in the north valley. Here's the problem: I don't know if I heard his name correctly because I was so freaked out over what happened to me, and over the sound of both our cars. It was either Luis, as his first name...or Ruiz as his last name. I don't know which he gave me. What I'm hoping is that you can narrow it down by shift and location to know who this is. Here is what happened:

Last night around 10-10:30 pm I was leaving a friend's house near downtown Abq. I was pulling onto Broadway by that main post office, and misjudged the speed and proximity of the guy coming towards me in the right lane and accidentally cut him off so he had to get into the other lane to go around and avoid me. At this point he was in front of me and was waving his hands around gesturing to me...not sure if he was flipping me off or what. It was dark and rainy. Then he reached back in his car and stuck his hand out the window again...this time with a gun. I freaked out and slowed down a lot to gain some distance between us and then decided to turn down another road...and he flipped a u-turn. He went down some side streets and waited in a parking lot for me to pass him and then pulled up behind me. Eventually he came up beside me and I slammed the breaks so he would be ahead of me again, and he pulled back in front of me. He pulled into a gas station parking lot on Candelaria and 2<sup>nd</sup> street and I was sure he was waiting for me to pass him so he could get behind me again, but he didn't. I kept watching in my rear view mirror and as I got closer to the Police Academy I saw a cop getting ready to pull out of the Academy and I pulled in to talk to him. I explained what happened and he was very kind and calm. The guy didn't appear to be following me anymore, but this officer asked me where I was headed and how I planned to get there. I was headed home to the west side and planned to take Paseo, so he said he would follow me for as long as he could. He followed me all the way to Paseo, checking to make sure it didn't seem we were being followed, and then pulled up next to me to tell me he couldn't go any further and that it seemed safe at that point. I thanked him and drove home...of course still very shaken up.

I know APD, and cops in general, get a lot of bad attention and complaints, and I wanted to do something just the opposite. I know our officers face a lot of challenges these days doing their jobs, and you should know just how great they are. I'm so thankful for this officer making me feel a little safer last night. I hope that based on the time and location and general name (sort of) that I have for this officer, that you will be able to narrow it down and give him and his supervisor the kudos he deserves. Maybe there is video footage from the academy that you could see? Anyway, I just wanted to let you know that I appreciate APD and this officer in particular. Thank you for all you do for our community!








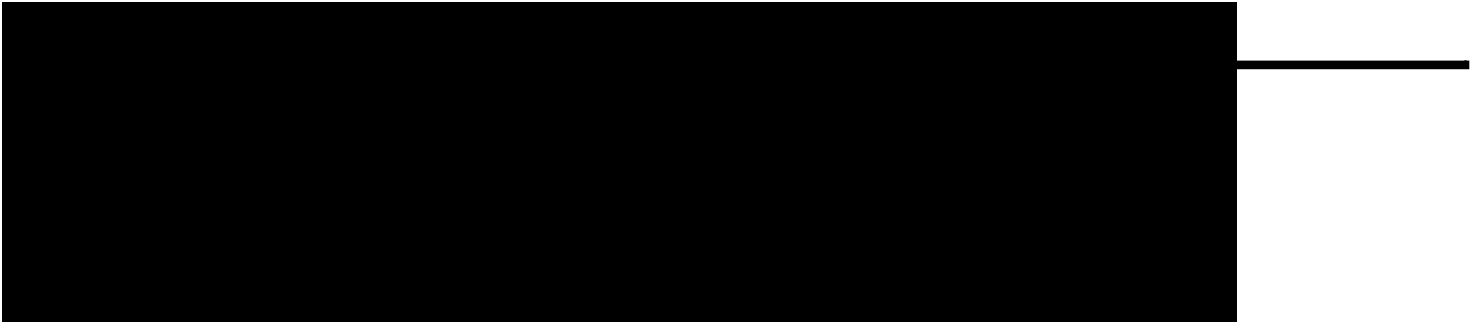


Statement

When I got back to the substation for booking I was sobbing and the arresting officer gave me some really helpful information flyers containing assistance. He informed me he would not charge me with paraphernalia and told me, "I'm not going to kick you while you're down but I hope that you follow up on help and if there's anything I can do to assist please let me know." Years later I wish I could personally reach out to that officer and thank him because he changed my life that day with his kindness and I am forever grateful. I have turned my life around, went to school and today I am a nurse and sober. That day, that officer realizing that a criminal charge was only going hurt me and future for the rest of my life but rather showing compassion genuinely was an aid in my success. So if that was you, thank you and God Bless.

What Outcome are you Seeking?

I just want officers to know that although they put up with a lot of scrutiny and I could imagine that its very easy to become jaded and desensitized because just about every person is in some kind of crisis your kindness does not go unnoticed. People's lives and futures are in your hands everyday and the decisions officers make in their profession have ramifications that can extend years or a lifetime. The work officers do is often under appreciated and people are quick to complain but I hope that APD knows that the job they do everyday doesn't go without acknowledgment especially when done with grace, understanding, and compassion.
