It was the evening of July 12 around 1900, there were two German Shepherd puppies that managed to get in to my fenced backyard. They've been here Sunday before this. My neighbor said the puppies were at her backyard Saturday night when there was fireworks near our community. She was thinking they got scared from the fireworks and found shelter at her backyard. So on Sunday morning I found them under my strawberry patch planter box. Very thirsty because it was hot those two days. I put water near them. I called the 311 number to report it and the operator said she will forward my report to Animal Welfare, which my neighbor did on Saturday night as well but nobody came. I let the dogs stayed in my backyard because they were comfortable. That Sunday night there was fireworks again and it scared the dogs away that night. I found it out on Monday morning when I was about to check on them. They were gone from where they were. The whole day of Monday, they were not in my backyard so I was hoping the owner found them. On Tuesday afternoon when I got back from work, that afternoon it rained hard with thunder. All of a sudden the puppies were back in my backyard and were drenched in water. That evening I tried to figure out a way to really have someone come and get them, when all of a sudden I saw in the other side of my property, which is a vacant lot, a police pick up truck parked and the officer was checking on something. I got up on a chair so he could see me and asked for his help with the dogs. It was officer Phil Moya who came with his buddy officer Brian Shannon. To make the long story short, they struggled really hard to get the puppies from underneath the strawberry planter box. They were very careful and considerate of the puppies. They said they were not really trained how to rescue dogs from underneath but they did so well. After putting the alternative leash on the puppies, they called an operator and see if anybody can take the dogs to the shelter but apparently there was no one available so they ended taking the dogs themselves. It was a big relief for me since I am not really a dog person and I didn't know how to handle them. There was no dog tags to identify the dogs. Officer Phil said that if the puppies have no owner, he might adopt them. I hope he did! I also asked them for permission to report their good deed to your office just so you know that there are still a lot of great police officers around despite all the negative reviews on your department. I also asked for their pictures with the dogs and posted it on Facebook, with their consent, so people will know that they were my heroes and angels in blue uniforms! I hope your office will give them the appropriate recognition and reward for what they did! Thank you for your service everyone! God bless you all!







Because of COVID restrictions we were waiting outside at the ER. Officer Martinez-Licon talked to us then went inside and talked to my mother.


