Commander Barraza:

I want to thank you on behalf of myself and Pat Hurley neighbors for the excellent job SW Area Command did in handling the chaotic situation on the 4th of July at Pat Hurley Park that has grown in size with every passing year. Over the years residents here have tried to work with APD and various city officials and agencies to help us combat the growing crime and violence in this area. Gun fire here is an every night occurrence. My own house has been hit twice with bullets. Pat Hurley Park on the 4th of July with no oversight was a disaster waiting to happen as we all have now seen the news of shootings in crowds that happened across the nation on the 4th. Commander, you had the professional foresight and immediate grasp of the situation to develop a plan and implement it on short notice with incredible timing and efficiency.

By 8:30-9:00 p.m. on the 4th, cars were packing onto La Bajada Rd., Yucca, and surrounding areas, the park chaotic with an overload of people. Officer Clay Blalock was the first officer I had contact with and I want to commend him for his no-nonsense skill and ability to communicate and assure us that the situation was going to be brought under control and immediately got to work. I also want to commend Sergeant Lujan and Lt. Casados with the PR Team. This was a full-on, well executed, precision police operation that showed incredible coordination. In my 25 years of living here, I have never seen anything like it.

APD closed the park at 10:00 p.m. and still weren't done. Officers came back at 11:00 p.m. to handle the people that had snuck back in. I also want to thank the AFD for working in conjunction with APD to ensure the safety of everyone. It makes me believe again what Albuquerque could be without all the crime.

Moving forward, I hope that plans continue to be developed to enhance the safety and security of this area. Commander Barraza, thank you.

I am blown away at the kindness and patience this APD officer demonstrated. On August 24, 2023 around 9:25 pm, I watched two officers begin to arrest and question a homeless man who was a suspect in an incident where another person was allegedly hit with a pipe. The homeless man was elderly and had a black eye (or similar injury). The homeless man was verbally belligerent, was refusing to sit down, and was not mentally processing what the officers were saying. One of the two officers was incredibly kind, calm, and patient. He did a fantastic job de-escalating what could have easily been a contentious interaction. The officer patiently repeated himself, addressed the man's concerns, was quick to read him his Miranda right, tried to make sure he really understood his Miranda rights instead of blazing past them. He had his lapel camera light on to make sure the video was clear since it was nighttime. Shortly after, another officer came up with a case update, and the homeless man was let go because he was no longer a suspect. Instead of just leaving, the officer sat the homeless man down and said "okay, now that we are done with that. What do you need? What can we do for you?" I was so moved by this officer's willingness to go the extra mile to help this man who was being belligerent. So many people would have lost their temper and made the situation. I have never left a commendation for an officer before. But I felt like this officer needed to be recognized. It makes me proud to live in Albuquerque.

I don't have the officer's name. He was tall, white, fit, likely in his 20s. Dark brown or black hair. Maybe had tattoos on his arms. It was the officer who read the homeless man his Miranda rights.
