We had just arrived from out of town. It was around noon and we could not get into our hotel till 3:00. We decided to have lunch and shop at Old Town. We parked in a paid lot facing a 4 lane street. When we returned to our vehicle a little after 3:00 PM, it had been cleaned out with the exception of suitcases of clothing and dirty clothing. My husband suffered kidney cancer this past year. I too am on several medications. They took our medications, my contact lenses, glasses, orthodontic retainer, my cameras with all our vacation pictures, and anything else not glued into place. We were in the 8th day of a 3 week trip. Understandably, we were very upset. The officer that came out, T. Wolffbrandt was so kind and patient with us. Though this may be routine for you, he understood what an upsetting experience it was for us. In MN, we routinely leave stuff in our vehicle without even a second thought, so this was unthinkable. I can't tell you how much it meant to us that the officer was so kind at this very upsetting time for us. It is very easy to become complacent to what you may consider routine and minor, he did not. It was extremely upsetting and stressful knowing we were without medications, contacts, glasses and orthodontic retainer. Unfortunately we had to cut our trip short and head home due to the inability to get some of our medications. We always honor, respect, and thank the police for their service. I want to take this opportunity to thank the kind officer, it made an experience that was traumatic to us less so.

On 9/29/16 at about 0850 on I-25 S, I was hit from behind by another vehicle as I was trying to exit the freeway. I had to do a panic stop because of the vehicle in front of me had just rear ended the vehicle ahead of her. Thankfully, I was able to stop in time and nobody was hurt. The gentleman behind me who could not stop, hit me. He then called 911. About 10 minutes or so latter, the Help truck arrived behind us and checked on our well being. Then, about 20 minutes latter, Officer Chavez arrived on his motorcycle and took charge. He was very courteous to the four of us and for our welfare. In this day and age of Police bashing and bad mouthing of APD and all other Law Enforcement Officers, I felt I had to give, what we say in the USN, a ' BZ'. That means 'outstanding job'. Thank him for me please! Chief Petty Officer USN Retired.
