Statement

I would like to commend Office Moya for demonstrating extraordinary attentiveness in my neighborhood and remarkable courtesy towards my wife and myself this evening – January 2, 2018 – approximately 6:00pm. The situation unfolded as follows: As I was leaving a family members house, (near Nakomis and Lomas NE) I noticed, and overtly watched, a white truck drive through the looped street (Pawnee St. NE). The fact that it did not stop caught my attention and stirred suspicion. As I drove home and entered my neighborhood (Cibola), I noticed a vehicle had been behind me for a number of turns. Feeling it might be that white truck, I pulled to the side of the road to let the vehicle pass. It was not the truck but as I resumed my drive, a second white truck pulled in behind me. I immediately took an alternate road leading away from my house and then again pulled over. This time, the vehicle stopped behind me for a moment or two, and then slowly proceeded forward. The truck turned out to be Officer Moya's marked SUV. At the next intersection, Officer Moya turned right but as I turned left, he turned around and pulled in behind me just as I pulled into my driveway. He had been observing my unusual behavior since entering the neighborhood. Once he ascertained the situation was harmless, we had a nice discussion regarding safe practices during criminal encounters and such. Coincidentally, my wife had arrived home moments before me and was also in the driveway. She inquired about an APD officer coming to her elementary school for lockdown training. Officer Moya took her contact information and said he would pass it along to the appropriate individual.

Overall, Officer Moya's demeanor was extremely professional, polite and courteous. His actions, personality and behavior made my wife and I feel very comfortable personally, and demonstrated that our neighborhood was being watched very closely. We are very grateful for the service and sacrifice APD Officers demonstrate every day and it was a pleasure to have this encounter with Officer Moya this evening. Thank You All Very Much!
