Our daughter's car was stolen from our driveway between 7am and 9am on a workday and the thief left a nearly destroyed similar year and color of car parked at the curb with the engine running. This situation was very disconcerting to my wife and after calling me she called 911 instead of 242-COPS. APD Officer G. Ronzone arrived very quickly (I advised my wife it might take some time due to current call loads for APD) much to my wife's relief. Officer Ronzone was very professional while expressing concern and understanding of my wife's worry about the deserted running car at our curb. I am sure to Officer Ronzone this may have been another of many stolen car reports, a rather routine call for service. If so that was never reflected in her attitude or demeanor, rather she was empathic to my wife's feelings and also expressed that the police share the frustration with the high stolen car rate in the city and are trying many tactics and strategies to reduce that rate. My wife had an appointment and I arrived home a short time later and Office Ronzone was just finishing her report while a tow truck finished loading the abandoned car. My experience with Officer Ronzone was just like my wife's and we both want to commend her for such an affirmative interaction and quality police response with an officer in a department that is experiencing some public trust issues. She reaffirms our belief that there are many great officers in the department.

My Dad said he was fine the officer wanted to make sure that he was. He said sometimes the adrenaline could mask signs of pain etc. I was so grateful for them being there. I did not know what I would have done. During the this process they protected us from a suspicious character either drunk or something walking towards us from across the street. They guided us and made sure we stayed behind the side of the gas station wall and not come out until they had that separate situation under control. I believe they got the situation under control and ended up arresting this individual. The protection they provided during all of this chaos was unbelievable. I think we forget that these kind of nights are normal for them. We, me and my Dad are so very thankful for these officers and I could not, not say or acknowledge them for there efforts and true protection. We are truly thankful.
