I am here to speak to the public at large.

The CPOA's executive director is in violation of a federal court order (Court Approved Settlement Agreement paragraph 183) and, most likely, the requirements of his contract. And he has done so with the full cooperation of this board.

On May 2, 2019, the federal monitor reported to the court that the CPOA administrative office and, in turn, this board are not in operational compliance when it comes to interviewing complainants when preforming investigations. The monitor compliance recommendation (4.7.169a) is "Interview all witnesses. If known witnesses are not interviewed, explain, in writing, why they were not interviewed."

To put it simply, the executive director, with this board's approval, has not conducted investigations that are thorough and in compliance with a federal court order.

On July 16, 2019, over three months after the federal monitor's report, 5 members of this board (barely a quorum) failed in their duty to supervise the executive director and knowingly approved the executive director's unlawful actions by administratively closing at least two cases wherein the complainant was not interviewed. (for the record here I'm referring to CPC 065-19 and 066-19)

On August 8, 2019, over four months after the federal monitor's report, the public learned that another case was placed on this board's consent agenda by the executive director to be administratively closed wherein, once again, the complainant was not interviewed. However, the complainant filed public records requests and obtained significant information not reported in the investigation. She appeared at that meeting and persuaded the board to table the question and send it to the case review committee for a recommendation.

It is my understanding that since that time the case did not go to the case review committee for open public discussion and recommendation to the full board today. Instead the full board voted to not administratively close the case, assumedly, by holding a secret rolling quorum outside of the public's view in violation of the New Mexico Open Meetings Act. I suspect the full board went into damage control and decided breaking the open meetings law was preferable

to further exposing their executive director's law breaking and, in turn, their own. (for the records here I'm referring to CPC 144-19)

Today there are 40 cases set on the consent agenda recommending the Board approve an administrative closing. How many of the complainants in these cases were not interviewed? We will see if the board cares to ask if known witnesses were not interviewed, and, is it explained, in writing, why they were not interviewed? Absent that simple question the board continues to allow their executive director's actions that prevent achievement of operational compliance with the federal court order.

As a member of the public who played a pivotal roll in creating the very seats the members of this board and the executive director occupy, it is sad for me to realize that I wasted my precious time and money to see the CPOA bastardized.

I implore the public at large to petition the Albuquerque City Council to follow their own unfulfilled CPOA ordinance (Section 9-4-1-11) requirement and issue a Request for Proposal for an independent consultant to undertake a complete evaluation and analysis of the entire police oversight process and recommend any necessary changes or amendments that would appropriately improve the process.





Re: SOP 2-8 On Body Recording Devices

Dear Chief Geier and the Albuquerque Police Department,

The Civilian Police Oversight Agency Board writes concerning SOP 2-8 On Body Recording Devices. Currently, videos that are considered non-evidence are deleted after 120 days. The Civilian Police Oversight Agency Board asks that you consider retaining non-evidentiary videos for a period of at least one year.

Often, videos that are relevant to the investigation of citizen complaints are categorized as non-evidentiary. Moreover, many citizens often come forward well after 120 days and at times civilian complaints take several months to complete meaning that video might be lost while an investigation is ongoing.

Far more often than not, videos relevant to civilian complaints exonerate the target officer(s); therefore, it is in the interest of the department that these non-evidentiary videos be retained for longer than 120 days. In the few instances where videos do not exonerate the officer, all parties can rest assured that the correct conclusions were drawn from the most objective evidence available. Both the public at large and the department's officers benefit when the reliability of the CPOA's investigations increases.

For these reasons, we ask that you modify SOP 2-8, extending the retention time frame for non-evidentiary videos from 120 days to a period of at least one year.

As an aside, the Board has discussed the muting capabilities of the department's OBRDs. We are curious and interested to see how the rules surrounding the muting capacity might be drafted and incorporated into the next iteration of SOP 2-8, and we may make further comment regarding this functionality in the future.

The Civilian Police Oversight Agency Board is in receipt of SOP 2-30 Emergency Command Post; SOP 2-97 Harm Reduction Act; and SOP 3-16 Seniority. The Board received these policies on August 26, 2019 after they were approved by the Policies and Procedures Review Board on August 24, 2019.

As a general rule, the Board is committed to providing feedback, commentary, and recommendations on all policies implicated by the Court Approved Settlement Agreement (CASA). At times, the Board may also provide feedback, commentary, and recommendations on policies that are not implicated by the CASA but that are of particular interest to the Board, the community, or the Board's mission of advancing constitutional policing.

We note that these SOPs do not pertain to the CASA. The Civilian Police Oversight Board makes no recommendations on SOP 2-30 Emergency Command Post; SOP 2-97 Harm Reduction Act; nor SOP 3-16 Seniority.
