




### SOUTHWEST

**Case 220050767** at 619 Shire St SW - On 07/03/2022, officers were dispatched in reference to a shooting. Officers on scene advised that a physical altercation occurred between two brothers at the listed location and resulted in a shooting. It was also advised that the victim was shot in the leg by his brother, Hansen Monte, who was seen walking in the Mesa after the shooting. Both the victim and offender were transported to UNMH by ambulance. Officers made contact with the victim who stated he and his brother got into a physical altercation because his brother was “trying to get with his girlfriend”. The victims stated after the altercation, Hanson got a firearm and shot him in the leg. After shooting his brother Monte he put the firearm back in the barrel in the victims room. Detectives were not able to locate the firearm in the room at the time of the search. On 07/06/2022 the victim passed away due to is GSW and Monte was arrested for Murder.



## VALLEY

**Case 220060426** at 408 12<sup>th</sup> St SW – On 08/06/2022, Marvin shot Daniel in the pelvis after Daniel approached him with a knife, threatening to mess him up. Marvin went outside to his truck when Daniel came outside with a Knife. He walked toward Marvin stating that he would mess him up while wielding a knife, approximately 12 inches long. Marvin feared for his life and shot Daniel in the leg. He aimed for Daniel's leg because he did not want to kill him, but he did not want to get stabbed either. Daniel retreated away from Marvin and onto the curb approximately 30 feet away.




**Case 220075032** at 1023 La Luz Dr NW – On 09/25/2022, a witness stated he was at home when he heard numerous gunshots outside. He then exited the residence and he observed a victim inside of a vehicle bleeding heavily. He then contacted emergency services and began rendering aid to the victim. Officers at the scene conducting witness canvassing encountered a male subject, later identified as Marquis Valdez. Marquis was making suspicious statements regarding the incident. A ShotSpotter activation confirmed that at least one firearm was discharged in front of 1013 La Luz Dr NW, just prior to the call for service regarding the shooting. A casing was located on the ground in front of the residence. Detectives obtained and executed a search warrant for Marquis's home. Officers located a firearm and casings during the execution of the warrant. Marquis stated that he wanted to tell officers the truth earlier; however, he was advised by his mother not to talk. He stated there has been an ongoing issue with the victim. He admitted that during the altercation, he shot at Matthew. Additionally, he said that after he shot Matthew, he picked up the casings and hid them along with the firearm. He informed officers on the scene where he hid the firearm and casings. An arrest warrant was drafted for Marquis on the charges of Aggravated Battery, Shooting from a motor vehicle, Use of a firearm, and Tampering with evidence. He was transported and booked into the Metropolitan Detention Center.



**Case 220073444** at 320 Gold Ave SW – On 09/20/2022, Jacob Reyna was arrested on negligent use of a deadly weapon, resisting/evading arrest, Aggravated burglary, and receiving/transferring stolen firearm, following a ShotSpotter activation.

## SOUTHEAST

**Case 220054233** at 7610 Central Ave SE – On 07/15/2022, after being choked and thrown against the wall Sherry drew her Glock 43X 9mm handgun from her appendix and fired at Jonathan. She stated that she has PTSD from prior domestic violence incidents and was in fear for her life when she fired her firearm. She stated that she fired all of the bullets that were inside of the magazine (approximately 12 9mm rounds). Jonathan told her that she shot him and fled the area. After the altercation, she ran upstairs and placed her firearm on the nightstand of their bedroom, and called 911. At approximately 2208 hours Albuquerque Fire and Rescue called and advised dispatch that a male subject showed up at Station Five with a gunshot wound to his shoulder. Jonathan Charlile was arrested for Domestic Violence charges.




## NORTHEAST



**Case 220054962** at 6000 Topke Pl NE – On 07/18/2022, officers were dispatched in reference to a disturbance. Prior to police arrival several individuals called 911 stating there was a large fight happening in the parking lot between several individuals. As the fight progressed one subject shot another subject. The victim left the scene in a Toyota driven by his wife. The victim and his wife located a PSA at Montgomery and Monroe and stopped for help. Albuquerque Ambulance was on scene at this location and transported Raul Gallelgos to the hospital where he was pronounced deceased. Officers arrived on scene at 6000 Topke PL NE where they located

several individuals in the parking lot. It was determined that the victim arrived at 6000 Topke PL NE when a large fight broke out in the parking lot between the two families when Michael Koester pulled out a gun and shot the victim. Homicide conducted several interviews with witnesses and involved individuals in this case. The shooter Michael Koester requested an attorney before providing an interview. Michael Koester was arrested and booked into MDC for second degree murder.

**Case 220067561** at 8123 Waterbury Pl NW – On 08/31/2022, Michael Runio-Maestas negligently fired a firearm from his home. Officers arrived on scene to check the immediate area saw the southeast gate on the side of the house open and could see straight to the backyard of listed address. The ShotSpotter App indicated that the two activations were fired from the backyard or the street (Parkway Dr. NW) behind it. An anonymous neighbor flagged officers down saying that she heard the gun shots as well. This neighbor went back to look at her security video and stated that at the time of the shots, no vehicles were seen driving on the street and no persons walking by. Michael Runio-Maestas was discovered to be the shooter and was arrested.

**Case 220055878** at 12700 Mountain View Ave NE – On 07/21/2022, officers issued a summons for David Arredondo for negligent use of a deadly weapon when they received a shots fired call located at 12700 Mountain View Ave NE with a ShotSpotter activation.

**Case 220074505** at 13001 Singing Arrow Ave SE - On 09/23/2022 Dominic Montoya was arrested for negligent use of a firearm as well as unlawful carrying of a deadly weapon. Officers walked south toward the arroyo and saw Montoya as well as two other unidentified individuals at the top of the arroyo. Officers identified themselves as Albuquerque Police Officers and told them they heard a gunshot coming from the area. Montoya said that he was in the area grieving over his father's death. It appeared that Montoya was intoxicated because his speech was slurred. Montoya stated that he had a firearm in his pocket that was concealed and that he did shoot a round into the air. Officers removed

# APD Crashes and Claims:

- ▶ Two categories are being tracked by the department related to claims paid.
- ▶ 3<sup>rd</sup> party claim payouts are related to bodily injury and property damage
- ▶ 1<sup>st</sup> party claim payouts are related to damage to City property. Usually a single vehicle crash (fixed object, curb) and City vehicle vs. City vehicle.

# Crash Review Board Members

- ▶ The Crash Review Board is comprised of the Traffic Division Commander, Traffic Lieutenant, a Motor Sergeant and a Motor Officer. All are crash reconstruction certified. The Operations Review Fleet Detective and the APD Safety Officer are also on the board.
- ▶ The board reviews crash reports, photographs of the crash and will hear statements from those involved if they so choose to present their case.

# Crash Review Board Decision Categories

- ▶ There are three categories a crash will fall under:
  - ▶ Non-Preventable
  - ▶ Preventable
  - ▶ Non-Crash
  
- ▶ The Crash Review Board will also identify employees who have had 2 or more preventable crashes within a 12 month period.





Force cases are now categorized by three levels. If a case involves multiple applications of force, it is categorized as the most serious at the case level. These counts are not considered final as investigations are continuously updated.

- Level 1 is force that is likely to cause only transitory pain, disorientation, or discomfort during its application as a means of gaining compliance. This includes techniques which are not reasonably expected to cause injury, do not result in actual injury, and are not likely to result in a complaint of injury (i.e., pain compliance techniques and resisted handcuffing). Pointing a firearm, beanbag shotgun, or 40 millimeter launcher at a subject, or using an ECW to “paint” a subject with the laser sight, as a show of force are reportable as Level 1 force. Level 1 force does not include interaction meant to guide, assist, or control a subject who is offering minimal resistance.
- Level 2 is force that causes injury, could reasonably be expected to cause injury, or results in a complaint of injury. Level 2 force includes use of an ECW, including where an ECW is fired at a subject but misses; use of a beanbag shotgun or 40 millimeter launcher, including where it is fired at a subject but misses; OC Spray application; empty hand techniques (i.e., strikes, kicks, takedowns, distraction techniques, or leg sweeps); and strikes with impact weapons, except strikes to the head, neck, or throat, which would be considered a Level 3 use of force.
- Level 3 is force that results in, or could reasonably result in, serious physical injury, hospitalization, or death. Level 3 force includes all lethal force; critical firearms discharges; all head, neck, and throat strikes with an object; neck holds; canine bites; three or more uses of an ECW on an individual during a single interaction regardless of mode or duration or an ECW application for longer than 15 seconds, whether continuous or consecutive; four or more strikes with a baton; any strike, blow, kick, ECW application, or similar use of force against a handcuffed subject; and uses of force resulting in a loss of consciousness.

### September 2022 Force Events





#### Call Types Associated with September 2022 Force Events





## Executive Director Report—September 8, 2022 Board Meeting

- I. Since the September 8, 2022 meeting, CPOA has received:
  - a. 12 driving complaints (predominantly from 311)
  - b. 31 new CPCs
  - c. 3 commendations
  
- II. Additional data
  - a. Average caseload for investigators is currently 18 cases (contrast with IAFD, for example, which was at 6.5 as of last week's EFIT hearing)
  - b. The vast majority of our cases are being finished at or just before the 120 day mark. There are, however, currently 18 cases that are past the 120 day mark. None of them are expected to have sustained findings. At least three of these are late due to a need for refinement in the writing of the report. This does not count any of the investigations that are suspended due to officer FMLA or military leave.
  - c. The backlog of cases left undone from 2020 & 2021 due to covid and lack of staff is 88. These cases are planned and/or in progress with the contractor firm, RCI.
  
- III. In response to member Wartell's inquiry at last month's meeting, the vast majority of officer interviews are being done via Zoom rather than on the phone. The primary reason for an officer interview not to be conducted by zoom is when there are technical difficulties and/or a bad zoom connection. The other reason we allow phone interviews with officers is when the choice is between conducting the interview now by phone because the officer has a gap in their schedule or continuing to try to find a mutually convenient time for a Zoom, which can drag out the process. However, in deference to the expressed concern, going forward, when an investigator conducts an officer interview by phone rather than Zoom, they will make a note in their report about the circumstances surrounding that decision.

In person interviews remain impractical at best in the current office space occupied by the Agency. Our investigators remain on a rotation for when they come in, and still frequently have to share office space, none of which is conducive to a good interview.

We also remain more willing to allow phone interviews with complainants and civilian witnesses as much of the population that we serve doesn't always have the technological access to conduct Zoom interviews.

- IV. In response to Chair French's inquiry at the last meeting about the outstanding protest cases: 157-20 and 158-20 were duplicative with IAFD investigations, so they are in IAFD hands. It is our understanding that 157-20 is tentatively scheduled to be presented to the FRB on December 10. 158-20 is still a part of the backlog that the secondary EFIT team is dealing with. 159-20 is still in process; we're working on finalizing the report.



- V. I have a couple of examples of the business cards that were produced for CPC members which might also serve as a template for Board business cards.
  
- VI. Retired Judge Victor Valdez started work as the Superintendent of Police Reform on September 12. He has been vocal about his eagerness to speak to and work with stakeholders in the reform process. Would the Board like to extend him an invitation to speak at November's meeting?
  
- VII. The primary takeaways from last week's hearing in front of Judge Browning on the EFIT report were:
  - a. Things are going well with EFIT and everyone is optimistic about their handing back control to IAFD in a timely manner;
  - b. Similarly, the frequency of UOF being out of policy has gone down from 10% of case to
  - c. Staffing of IAFD remains the biggest challenge to long term sustainability of the gains seen under EFIT, but the department is working to remedy that issue;
  - d. Flaws in an investigation's following of the process narrative do not necessarily equate to flaws in the end product;
  - e. UOF data is trending in the right direction, with both uses of force per month and percentage of uses of force found to be out of policy going down. Uses of force have gone from approximately 50/month to 35/month. Out of policy uses of force have gone down from approximately 10% of those cases to 5.45%; and
  - f. While there is widespread concern about the civilian investigators unionizing specifically under APOA, there is no objection to their unionization generally.
