- i. Gabe Remer provided information on the responses he received from APD regarding general policies for SOP 1-80 Prisoner Transport Unit (PTU). Civilian Police Oversight Agency (CPOA) Investigators recommended that SOP 1-80 be revised to explicitly state severe intoxication in the refusal criteria under Section 1-80-5-A. Additionally, the CPOA submitted a pre-PPRB recommendation that was accepted by APD for this policy.
- ii. Gabe Remer stated the APD author for SOP 1-80 included additional information that the University of New Mexico Hospital (UNMH) will no longer be staffing medical personnel Civilian Police Oversight Advisory Board Policy and Procedure Review Subcommittee

for pre-intake screening at the Prisoner Transport Center (PTC).
Gabe Remer further stated UNMH practice was beneficial;
however, that position is no longer being staffed, and these issues
have largely gone unchecked.

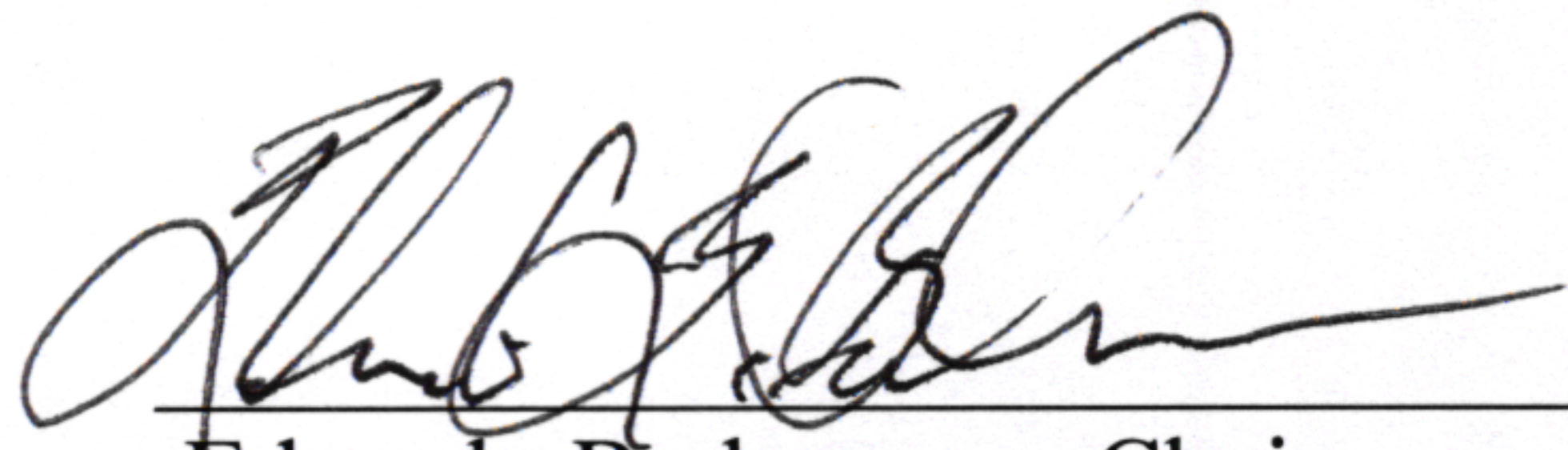
