

As requested via voice mail left on the Cleveland Water Lead Inquiry Line (January 1, 2022, 10:09 am), please find enclosed a variety of Lead and Copper education materials. These materials are part of our Lead Education Campaign (LEC) designed to meet Ohio EPA's recommended guidelines pursuant to changes to the Ohio Revised and Administrative Codes in 2018. Our LEC far exceeds the minimum requirements, many of our materials are used by other water systems in Ohio for their program needs, and in fact, we helped Ohio EPA develop their LEC guidelines. As you can tell, we are proud of this program and we hope you find solid information in this package.

NOT SURE THAT I CAN ACCOMPLISH MUCH BY SPEAKING OUT

Regarding your specific situation, we understand your frustration with not being advised of a potential lead service line serving your property prior to purchase. Many times this is uncovered during home inspections prior to sales and this can become a negotiated home sale condition. Please be advised that unlike some situations, such as asbestos and in some locales mining and radon, there is no current state law requiring lead service line disclosure by the homeowner. While a public water system like Cleveland Water can be contacted in advance of the sale to see if there is a likelihood the property is served by a lead service line in the public right-of-way, we almost never have information regarding the service line material located on private property. This is the piece of pipe extending from the shut-off valve at the property line all the way into the home. We also do not have any records of premise plumbing material inside the home. That is why we developed the "scratch test and magnet test" methodology - to help homeowners identify what they have and relay that information to us for inventorying purposes. This point has been communicated to you during previous phone conversations.

~~BUT~~ I DON'T ACCEPT YOUR DISTONORABLE We do have additional materials on our website regarding Lead and Copper. You have indicated you do not have a computer or cell phone to view these materials and videos. I recommend if you are interested in additional information that you

In fact, we have sampling locations from four places in Parma (West Ridgewood, Tuxedo, Albertly, and Fortune Ave.) and these sites all had excellent values during our last monitoring campaign in the summer of 2021 with all results below the detectable reporting limit for Ohio EPA. WITH INSTALLATION OF "BROADBAND" AND ULTRA HIGH SPEED "CRAP" IN THIS ENVIRONMENT.

We acknowledge that the presence of a lead service line, regardless of successful treatment, still presents a risk. Additionally, it is likely your home has copper plumbing and, based upon the age, likely has high lead solder joining pipe lengths, valves, and fittings. Faucets and plumbing fixtures manufactured before 2014 likely have high leaded brass components. Even if you did not have a lead service line, there would still be a risk to lead exposure coming from inside your home. That is why we will continue practicing Corrosion Control treatment forever and will recommend **Clean. Flush. Consume Cold** to all customers as part of a healthy water habit practice.





This information is crucially relevant for the Board to consider at the Board meeting tonight regarding the reconsideration request on the agenda for CPC #115-21. The information is from the published findings letters approved by the Board at their December 9, 2021, meeting. I only came across the information while reading the findings letters last night.

I request these relevant facts not only be considered but that they be read into the public record by any concerned Board member.

CPC #115-21 and CPC #148-21 were both reviewed and were Administratively Closed as the three officers no longer worked for APD.

- **CPC #148-21**

In this case it was explained that the investigator determined this *complaint did not merit subpoenaing Officer J*, since he is no longer with the department, as there were no observed policy violations, and Officer J served as backup and had no specific complaints reference him. The Complainant said Officer J was nice.

In this case Officer A was not interviewed, and he no longer worked for APD, and it was explained that *the investigation determined if the officer had been here the findings would have been like the other officers and not have sustained policy violations.*

- **CPC #115-21** – Was Administratively Closed with the statement “Please be advised the concerns involving Detective S were Administratively Closed as Detective S no longer worked for APD” without further explanation.

No explanations as in CPC #148-21 why the *complaint did not merit subpoenaing Detective S or the fact that there were no similar findings to other officers to compare with Detective S.*

I contend that the CPOA, by their own findings letters, demonstrate subjective, capricious, investigative standards when it comes to processes applied to Administratively Closing investigations when officers no longer are employed by APD.






### December 2021 Force Events



**Call Types Associated with December 2021 Force Events**




### November 2021 Force Events



Call Types Associated with November 2021 Force Events



# APD Crashes and Claims:

- ▶ Two categories are being tracked by the department related to claims paid.
- ▶ 3<sup>rd</sup> party claim payouts are related to bodily injury and property damage
- ▶ 1<sup>st</sup> party claim payouts are related to damage to City property. Usually a single vehicle crash (fixed object, curb) and City vehicle vs. City vehicle.

# Crash Review Board Members

- ▶ The Crash Review Board is comprised of the Traffic Division Commander, Traffic Lieutenant, a Motor Sergeant and a Motor Officer. All are crash reconstruction certified. The Operations Review Fleet Detective and the APD Safety Officer are also on the board.
- ▶ The board reviews crash reports, photographs of the crash and will hear statements from those involved if they so choose to present their case.

Our newest investigator that just started in Dec has recently started working cases. We have another investigator starting next week and our third investigator will be starting at the end of the month.

As you received the email the Court has granted an additional session to review the latest monitor report and to provide the amici the opportunity to present their letters and concerns. FY23 budget issues papers were submitted to the budget process. The requests included money for likely increased contractual services such as mediation and translation services as well as more funding for the CPCs. Monies for NM Captioning are being shifted from another area of the budget to cover the remaining costs of FY22 since the current allocation is almost exhausted. The contract is being increased for FY23

I am working with HR to get the policy analyst position drafted and posted. As to the time table for that I cannot say yet when HR will have it ready, but I am working closely on that. It is necessary to show movement on vacant positions during the budget process as the instructions the budget employees have been given is vacant positions will be removed from funding.

The letter the Board approved and delegated to be drafted to the CAO regarding increased office space is somewhat in a holding pattern because before it was sent the office with the assistance of the budget analyst put some individuals in contact with us. We are currently working with and exploring the options. If the process stagnates then the letter would be modified and sent out.

The NACOLE (national association for civilian oversight of law enforcement) occurred in Dec 2021 in Tucson. Members French and Kass were in attendance as well as many staff members. Two members expressed interest in attending the Nacole webinar on January 19<sup>th</sup> and are registered.

We are having challenges getting back equipment from some of the resigned board members. We have experienced long delays in the past as well. It is being mentioned for the purpose current board members could consider and discuss what they as volunteers would agree to when being appointed to ensure the return of the equipment when board members finish their terms or leave prematurely.
