#### MY BACKGROUND

After retiring here at KAFB in 1983 after serving 22 years as an USAF officer-one in Vietnam where I saw too many lives taken, I served for nine years as President of a District 8 Neighborhood Association President caring for 525 homes.

After my good neighbor Chris Hinz was murdered by Schultz's repeat killer cop Anthony Sedler and his partner Eric Brown on June 10, 2010 both of whom were never punished and months later another neighbor-a Navy SEAL with PTSD who just returned from Iraq would also have been murdered by APD had I not intervened, I stepped away from that President's job and dedicated myself to working with others to reform APD.

This included helping Jewel Hall President of the MLK Jr. Memorial Center to bring the DOJ here. I have been threated by Chief Schultz and Chief Eden's deputy Chief Bob Huntsman.

I often volunteered to serve on the former POC and also on the POB but was always rejected as APD deemed me too much of a threat to the status quo where both were kept toothless as you six are now. After Geier overruled you and kept Drobik in APD, you should have resigned in protest but you never did.

Like the old POC, you too are not allowed to do any oversight-only there to rubberstamp what Harness and his real boss-Chief Geier does

#### Good Afternoon,

In response to your request, unfortunately, I do not have that conversation recorded when I spoke with Christian's mother initially, and she told me that Councilman Ken Sanchez wanted to talk to me in his office the next day. When I spoke with her that time, I told her that I would have to ask my Sgt's advise on this and will call her back. I told Sgt. Hilger immediately that I did not record that conversation. He said "it's ok". Additionally, right after the conversation, I advised Sgt. Hilger about what Christian's mother had told me about Mr. Sanchez wanting me to go to his office the next day to talk about this case. After telling Sgt. Hilger this, he told me to tell her I cannot meet with Mr. Ken Sanchez.

I called Christian's mother back, and at this point, I recorded the conversation and told her that while I appreciated the invite but I have to deny that request, and cannot go to Councilman Sanchez's office to talk about the case. To the best of my recollection, Christian's mother understood this decision over the phone.

Furthermore when I wrote my original report on this matter, Sgt. Hilger advised me to delete a paragraph from my original report because he said it would just piss off the chain of command if I left it there. I deleted that paragraph and sent the report in without it. However, I kept a copy of the original report with the deleted paragraph in it. The same day, mysteriously, the case was taken away from me by Sgt. Hilger. I never spoke to Councilman Sanchez and I don't have any other material but for my original draft report.
