V. CPOA Report – Edward Harness, Executive Director

a) Memorandum of Understanding for Mediation. Director Harness will be presenting the final version of the Memorandum of Understanding for the Mediation process at the next Police Oversight Board (POB) meeting. A meeting took place with the DOJ, City Attorney's office and the APOA Attorney Mr. Amato to discuss the process and have decided on cases that involve an interaction between the officer and the citizen (communication), investigations and report documentation.

- **b)** New CPOA Investigation. The Civilian Police Oversight Agency has received a new complaint and it turns out that the officer's laptop/computer must be seized in order to do computer analysis. Since APD will not do the analysis on the computer, the CPOA office may have to contract this task out with a forensic specialist to analyze the computer.
- c) Force Review Board. Assistant Chief Huntsman will let Director Harness know if the FRB will be hearing the back the back log of officer-involved shooting cases. Director Harness will send an email to the members of the Case Review Subcommittee regarding this information.
- d) Institute for Social Responsibility. Director Harness met with Dr. McGuire and Dr. Verploegh from the University of New Mexico, who have come to an agreement to contract with the CPOA and the City of Albuquerque to conduct the data analyst work for the agency.
- e) Mayoral Round table About Public Safety. On September 13, 2017 from 6 p.m. to 8 p.m. at Hotel Blue on Central Ave. NW, there will be a mayoral round table about public safety. Member Fine will contact Brian Riley to inquire about the event.
