Chair Crawford noted that SOP 1-1 Personnel Code of Conduct, SOP 1-50 Gun Violence Reduction Unit, SOP 1-53 Homicide Unit, SOP 1-65 Metropolitan Court Protection Unit, SOP 2-13 StarChase Pursuit Management System, SOP 2-21 Apparent Natural Death or Suicide of An Adult, SOP 2-33 Rights and Safety of Onlookers and SOP 2-66 Victim and Witness Assistance will be reviewed at the June 15, 2022, P&P (Formerly OPA) meeting and that no action is required from the Policy and Procedure subcommittee on these policies at this time.
