- The Policy and Procedure Review Subcommittee recommends submitting a "No Recommendation" recommendation at this time for SOP 1-16, SOP 1-20, SOP 1-28, SOP 1-37, SOP 1-58, SOP 2-08, SOP 2-19, SOP 2-22, SOP 2-35, SOP 1-25, SOP 1-39 and SOP 2-02 to APD Policy and Procedure Unit (formerly OPA) and will present the recommendation at next regularly scheduled CPOA Board meeting for approval.
- 2. SOP 2-41 Traffic Stops has a pending data request at APD and the Policy and Procedures Subcommittee does not recommend a "no recommendation" recommendation on SOP 2-41 at this time.
